# MEGHALAYA STATE COMMISSION FOR PROTECTION OF CHILD RIGHTS

In keeping with the vision of the National Commission for Protection of Child Rights, the Mandate of the Meghalaya State Commission for Protection of Child Rights, is to ensure that all Laws, Policies, Programmes, and Administrative Mechanisms are in consonance with the Child Rights perspective as enshrined in the Constitution of India and also the UN Convention on the Rights of the Child. The Child is defined as a person in the 0 to 18 years age group.

The Commission visualises a rights-based perspective and in order to touch every child, it seeks a deeper penetration to communities and households and expects that the ground experiences gathered at the field are taken into consideration by all the authorities at the higher level. Thus the Commission sees an indispensable role for the State, sound institution-building processes, respect for decentralization at the local bodies and community level and larger societal concern for children and their well-being.

## **BACKGROUND**

With the aim of effectively addressing the issue of protection of child rights in Meghalaya, the State Com¬mission for Protection of Child Rights was set up. The Commission comprised of a Chairperson and six members including two women representatives.

The Government of Meghalaya, Social Welfare Department, vide Notification No. SW(S)112/2009/236 dated, Shillong the 28<sup>th</sup> February, 2014 under Section 4, sub-section (3) of the Commission for Protection of Child Rights Act, 2005 (4th of 2006) the Governor of Meghalaya appointed Smti. Meena Kharkongor as Chairperson, State Commission for Protection of Child Rights for a period of 3 (three) years with immediate effect.

The Chairperson joined the Commission on 11th March, 2014 and the office was opened on the 23<sup>rd</sup> May, 2014 at Nongshiliang, Nonthymmai, Shillong with a staff strength consisiting of only the Chairperson, one peon and a chowkidar.

The Commission functioned from the above address till February, 2015 thereafter shifted it's office to Lower Lachumiere, Shillong.

### BRIEF HISTORY OF SOME OF THE CASES, CHALLENGES & SUCCESS >

#### CASE NO. 1: CUSTODY CASE

Complaint was filed for custody of a girl child by the maternal grandmother from the father. The Commission held hearings and tried settling the matter with an aim for an amicable settlement, keeping the child's best interest at the forefront. However, ultimately the parties decided to approach the Courts having jurisdiction where the matter is proceeding.

#### CASE NO. 2: CUSTODY CASE

Minor boy who was granted custody to his father who had re-married. Upon complaint by the Mother of the child, the Commission took up the issue with the Child Welfare Committee whereby the Boy (Child) was re-united with his Mother.

#### **CASE NO. 3: VIOLATION OF CHILD RIGHT**

A case of a young boy being beaten up by the Dorbar Shnong nembers was brought before the Commission. The Commission intervened and the matter was then settled. Awareness was also given to the Dorbar on "Child Rights" and how they are to handle cases brought before them.

#### CASE NO. 4: RAPE CASE

Alleged Rape case of a teenager whose case is under police Investigation. The girl is receiving counseling provided by the Commission and her self- confidence is slowly growing.

#### CASE NO. 5: CHILD BEATING

A case of child beating in the city school reported in the daily newspaper was taken up suo-moto by the Commission. The matter is under Police Investigation and an Independent Inquiry has also been directed jointly by the Child Welfare Committee and the Commission, while the teacher is under suspension.

#### CASE NO. 6: CHILD LABOUR

On 20<sup>th</sup> June, 2014, the Chairperson, SCPCR was informed that there were some child laborers working in a Naga Food stall, Laitumkhrah, Shillong. Immediately the information was passed on to the District Child Protection Officers, Social Welfare Department, who then conducted raids with the Police and rescued two children below the age of 12 & 18 years. The children were then shifted to the shelter homes and ultimately restored back to their families outside the State.
