# VISION

In keeping with the vision of the National Commission for Protection of Child Rights, the Mandate of the Meghalaya State Commission for Protection of Child Rights, is to ensure that all Laws, Policies, Programmes, and Administrative Mechanisms are in consonance with the Child Rights perspective as enshrined in the Constitution of India and also the UN Convention on the Rights of the Child. The Child is defined as a person in the 0 to 18 years Age group. The Commission visualizes a right-based perspective and in order to touch every child, it seeks a deeper penetration to communities and households and expects that the ground experiences gathered at the field are taken into consideration by all the Authorities at the higher level. Thus the Commission sees an indispensable role for the State, sound Institution-building processes, respect for Decentralization at the local bodies and Community level and larger Societal concern for children and their well-being.

## ROLE OF MSCPCR

The State Commission for Protection of Child Rights (SCPCR) was constituted under the Commissions for protection of Child Rights Act, 2005 by the Govt. of Meghalaya on 28th February 2014. The Act empowers the Commission to act as a Civil Court, to undertake suo-motu enquiry and also look into complaints relating to deprivation and violation of child rights and non implementation of laws for protection and development of children. The Commission monitors rescue & rehabilitation of child labour, matters falling under the RTE Act, POCSO Act, JJ Act 2015, medical crises in schools, children's right to play in parks, prevention of sexual abuse of children, checking child trafficking and all issues connected with children in need of care and protection and children n conflict with law.

#### FUNCTIONS AND POWERS OF THE COMMISSION

Section 13 (1) of the Commission for Protection of Child Rights Act, 2005 lays down the functions of the Commission as follows:-

Examine and review the safeguards provided by or under any law for the time being in force for the protection of child rights and recommend measures for their effective implementation;

- b) Present to the State Government, annually and at such other intervals, as the Commission may deem fit, reports upon the working of those safeguards;
- c) Inquire into violation of child rights and recommend initiation of proceedings in such cases;
- d) Examine all factors that inhibit the enjoyment of rights of children affected by terrorism, communal violence, riots, natural disaster, domestic violence, HIV/ AIDS, trafficking, maltreatment, torture and exploitation, pornography and prostitution and recommend appropriate remedial measures;
- e) Look into the matters relating to children in need of special care and protection including children in distress, marginalized and disadvantaged children, children in conflict with law, juveniles, children without family and children of prisoners and recommend appropriate remedial measures;
- f) Study treaties and other international instruments and undertake periodical review of existing policies, programmes and other activities on child rights and make recommendations for their effective implementation in the best interest of children;
- g) Undertake and promote research in the field of child rights;
- h) Spread child rights literacy among various sections of the society and promote awareness of the safeguards available for protection of these rights through publications, the media, seminars and other available means;
- i) Inspect or cause to be inspected any juvenile custodial home, or any other place of residence or institution meant for children, under the control of the Central Government or any State Government or any other authority, including any institution run by a social organization; where children are detained or lodged for the purpose of treatment, reformation or protection and take up with theses authorities for remedial action, if found necessary;
- j) Inquire into complaints and take suo-motu notice of matters relating to:
  - i) Deprivation and violation of child rights;
  - ii) Non-implementation of laws providing for protection and development of children;
  - Non-compliance of policy decisions, guidelines or instructions aimed at mitigating hardships to and ensuring welfare of the children and to provide relief to such children, or take up the issues arising out of such matters with appropriate authorities; and
- k) Such other functions as it may consider necessary for the promotion of child rights and any other matter incidental to the above functions.

## **POWERS RELATING TO INOUIRIES**

As per Section 14(1) of the CPCR Act, 2015

- 1. The Commission shall, while inquiring into any matter referred to in clause(j) of sub-section (1) of section 13 have all the powers of a civil court trying suit under the Code of Civil Procedure, 1908 and, in particular, in respect of the following matters, namely:
  - a) Summoning and enforcing the attendance of any person and examining him on oath;
  - b) Discovery and production of any document;
  - c) Receiving evidence on affidavits;
  - d) Requisitioning any public record or copy thereof from any court or office; and
  - e) Issuing commissions for the examination of witnesses or documents.
- 2. The Commission shall have the power to forward any case to a Magistrate having jurisdiction to try the same and the Magistrate to whom any such case is forwarded shall proceed to hear the complaint against the accused as if the case has been forwarded to him under section 346 of the Code of Criminal Procedure, 1973.

#### **STEPS AFTER INQUIRY**

As per section 15 of the CPCR Act 2005;

The Commission may take any of the following steps upon the completion of any inquiry held under this Act, namely-

- i) Where the inquiry discloses, the Commission of violation of child rights of a serious nature or contravention of provisions of any law for the time being in force, it may recommend to the concerned Government or authority the initiation of proceedings for prosecution or such other action as the Commission may deem fit against the concerned person or persons;
- ii) Approach the Supreme Court or the High Court concerned for such directions, orders or writs as that Court may deem necessary;
- iii) Recommend to the concerned Government or authority for the grant of such interim relief to the victim or the members of his family as the Commission may consider necessary.

  Specific Mandate of the Commission as per some important Acts:
- i) The Right of Children to Free and Compulsory Education Act, 2009
- 1. The Commission, as per section 31 (1) of the RTE Act shall, in addition to the function assigned under the Act, also perform the following functions, namely:
  - a) Examine and review the safeguards for rights provided by or under this Act and recommend measures for their effective implementation;
  - b) Inquire into complaints relating to child's right to free and compulsory education; and
  - c) Take necessary steps as provided under section 15 and 24 of the Commissions for Protection of Child Rights Act.
- 2. The Commission shall, while inquiring into any matters relating to child's right to free and compulsory education under clause (c)of sub-section (1), have the same powers as assigned under sections 14 and 24 of the Commissions for Protection of Child Rights Act.
- 3. Under section 32(3) of the RTE Act, any person aggrieved by the decision of the local authority may prefer an appeal to the Commissions for Protection of Child Rights.
  - ii) The Juvenile Justice (Care & Protection of Children) Act, 2015

As per section 109 (1) of the JJ Act 2015, the Commission for Protection of Child Rights shall, in addition to the functions assigned to it under the CPCR Act 2005, shall also monitor the implementation of the provisions of the JJ Act, in such manner, as may be prescribed. The Commission shall while inquiring into any matter relating to any offence under this Act, shall have the same powers as are vested in the Commission under the CPCR Act 2005.

As per section 109 (3) the Commission shall also include its activities under this section in its Annual Report.

iii) The Protection of Children from Sexual Offences Act, 2012

#### SECTION 44-MONITORING OF IMPLEMENTATION OF THE POCSO ACT.

As per section 44 (1) of the POCSO Act the Commission shall, in addition to the functions assigned under the CPCR Act, also monitor the implementation of the provisions of the POCSO Act in such manner as may be prescribed.

As per section 44 (2) the Commission shall while inquiring into any matter relating to any offence under this act shall have the same powers as are vested in it under the CPCR Act 2005.

As per section 44 (3) the Commission shall also include its activities under this section in its Annual Report.

# **BACKGROUND**

With the aim of effectively addressing the issue of protection of child rights in Meghalaya, the State Commission for Protection of Child Rights was set up. The Commission comprised of a Chairperson and six members including two women representatives. The Government of Meghalaya, Social Welfare Department, vide Notification No. SW(S)112/2009/236 dated, Shillong the 28th February, 2014 under Section 4, sub-section (3) of the Commission for Protection of Child Rights Act, 2005 (4th of 2006) the Governor of Meghalaya appointed Smti. Meena Kharkongor as Chairperson, State Commission for Protection of Child Rights for a period of 3 (three) years with immediate effect. The Chairperson joined the Commission on 11th March, 2014 and the office was opened on the 23rd May, 2014 at Nongshiliang, Nonthymmai, Shillong with a staff strength consisting of only the Chairperson, one peon and a chowkidar. The Commission functioned from the above address till February, 2015 thereafter shifted it's office to Lower Lachumiere, Shillong.

# MEETINGS CONDUCTED BY SCPCR

## Meetings of State Commission for Protection of Child Rights

- 1. The meeting of SCPCR was held in the premises of the Commission where the Chairperson and members discussed on the proposed State Level workshop on POCSO Act and the JJ Act, initiated by the NCPCR, New Delhi to be held on 2nd December 2017 at the Shillong Club in collaboration with the NCPCR. A detailed discussion was held to involve all stakeholders dealing with Children and it was jointly decided to invite the Special Judges (POCSO Courts), Spl. Prosecutors, Police, and the Social Welfare Department. The Member- Secretary was asked to do the necessary work of sending out letters to all concerned.
- 2. The second meeting of the SCPCR was held on 13<sup>th</sup> April, 2018 where the Commission welcomed the new Member, Smti. Sume. G.B. Sangma. The Chairperson and members also discussed on the delay of the CPP (Child Protection Policy) which was still pending with Social Welfare Department, and it was felt that this urgent matter should be communicated to the Minister, Social Welfare, Govt., of Meghalaya., Other matters which were taken up were:-
- 3. To discuss on the letter which was sent to DHS (Directorate of Health Services) on setting up of Deaddiction centre for youths.
- 4. The other matter was discussed on the policy for regulating of private schools/play schools.
- 5. Discussion was also held on the Education Policy of the State.
- 6. After a thread bare discussion on the Agendas, it was felt and voiced by everyone present in the Meeting to approach the Health and Family Welfare Minister to discuss on the issues relating to setting up of De-addiction Centre for Youths in our State as well as to construct "Pink toilets" built specifically for women to raise awareness on Health and Hygiene Issues. The Commission as a whole decided to meet the Principal Secretary, Education Department to raise the issues concerning the Education Policy. The Commission has also entrusted Dr (Mrs) V. Kharmawphlang to initiate this matter. Later, on the same day the chairperson met the Social Welfare Minister, Govt. of Meghalaya and apprised him of the delay of the draft of the CPP and was assured that he would look into the matter at the earliest.

# **Complaint Hearing Conducted by SCPCR**

A Complaint Hearing was conducted by the Chairperson SCPCR, Smti. Meena. Kharkongor, Member SCPCR, Smti. V. Kharmawphlang & Deputy Director, DSEL, Smti. T. M. Pyngrope in the office of the Commission. The case was heard and disposed off on resolution drawn up by the School Authorities and the Complainant. Case disposed off.

## 11<sup>TH</sup> APRIL 2017

Programme was held at St. Mary's College on the Presentation on the POCSO Act, 2012 against Girl Child and the FAO's on RTE Act, 2009. The session was deliberated by the Chairperson, State Commission for Protection of Child Rights. The presentation on Protection of Children from Sexual Offences (POCSO) Act, 2009 was shown to the participants where all the relevant sections of the Act was explained in detail. The POCSO Act covers all children below the age of 18 years irrespective of gender. There are stringent punishment for offenders and Special courts are to try such cases preferably within one year from taking cognizance of the case. Abetment and Attempt to commit the offence is also punishable under this act. Burden of proof is upon the accused person. Media are barred to report cases which will disclose the identity of the victim and the punishment for violation shall be 6 months to 1(one) year with fine. This act is only applicable to child survivors and Adult offenders. If a child commits the offence, he/she shall be forwarded to the Juvenile Justice Board of the districts concerned.

The Right to Education Act, 2009 was explained in brief wherein all children of the age of 6 to 14 years coming from backward and downtrodden families were given Free and Compulsory Education through the government, Govt. Aided Schools and the SSA Schools. The RTE Act, 2009 still has a lot of shortcomings in implementation and the Education Department has a lot to do to improve the quality of Education in the state.


### 18<sup>TH</sup> MAY 2017



Proceedings was drawn up, the State Commission for Protection of Child Rights shall take up important issues with the Concerned Higher Authority of the government to address the same.


