The Bill for establishing the Commissions exclusively for protecting rights of children was first introduced in Parliament in 2003. Thereafter, it was referred to the Department- related Parliamentary Standing Committee on Human Resources Development. The Committee submitted its 165th Report in 2005 on the Commission for Protection of Child Rights Bill, 2005. The Bill was debated in Parliament and passed in 2005. It received the President's assent on 20th January, 2006.

The Commission of Protection of Child Rights Act, 2005 (CPCR Act) provides for the constitution of a National Commission and State Commissions for Protection of Child Rights. IT also provides for the establishment of Children's Court for providing speedy trial of offences against children or of violation of Child Rights. The Meghalaya State Commission for Protection of Child Rights was notified and established on 28th February, 2014.

The Mandate of the Commission is to “PROTECT, PROMOTE and MONITOR” Child Rights in any form. The Constitution of India stipulates Rights of Children and also imposes duties on the State towards Children. Article 15 (3) allows the State to make special provisions for Children, Article 21 A recognizes the Right to Free and Compulsory Education for children and Article 24 prohibits employment of children below the age of 14 years in factories, mines or any hazardous employment. Further the Constitution also imposes certain duties upon the State in the form of Directive Principles of State Policy, which are Articles 39 (c) and (f) and Article 45. It also imposes a fundamental duty under Article 51 (k) upon parents to provide opportunities for Education to their children.

The Meghalaya State Commission for Protection of Child Rights from its inception has been engaged in upholding the spirit of the Constitution by protecting and promoting the Rights of Children and many important steps have been taken up by the Commission for the Protection of rights of the children in the State to ensure that children have a protective Child- friendly environment.

Meghalaya State Commission for Protection of Child Rights (MSCPCR)

VISION

In keeping with the vision of the National Commission for Protection of Child Rights, the Mandate of the Meghalaya State Commission for protection of Child Rights, is to ensure that all Laws, Policies, Programmes and Administrative Mechanisms are in consonance with the Child Rights perspective as enshrined in the constitution of India and also the UN Convention on the Rights of the Child. The Child is defined as a person in the 0 to 18 years age group. The Commission visualizes a rights-based perspective and in order to touch every child, it seeks a deeper penetration to communities and households and expects that the ground experiences gathered at the field are taken into consideration by all the authorities at the higher level. Thus the Commission sees an indispensable role of the State, sound institution-building processes, respect for decentralization at the local bodies and community level and larger societal concern for children and their well-being.



BACKGROUND

With the aim of effectively addressing the issue of protection of child rights in Meghalaya, the State Commission for Protection of Child Rights was set up. The Commission comprised of a Chairperson and six members including two women representatives.

The government of Meghalaya, Social Welfare Department, vide Notification No.SW(S)112/2009/236 dated, Shillong the 28th February,2014 under section 4, sub-section(3) of the Commission for Protection of Child Rights act,2005(4th of 2006) the Governor of Meghalaya appointed Smti. Meena Kharkongor as Chairperson, State Commission for Protection of Child Rights for a period of 3(three) years with immediate effect.

The Chairperson joined the Commission on 11th March,2014 and the office was opened on the 23rd may,2014 at Nongshiliang, Nongthymmai, Shillong with a staff strength consisting of only the Chairperson, one peon and a chowkidar. The Commission functioned from the above address till February, 2015 thereafter shifted it's office to Lower Lachumiere, Shillong.

FUNCTIONS AND POWERS OF THE COMMISSION

Functions of the Commission

Section 13 (1) of the Commission for Protection of Child Rights Act, 2005 lays down the functions of the Commission as follows:-

- a. Examine and review the safeguards provided by or under any law for the time being in force for the protection of child rights and recommend measures for their effective implementation.
- b. Present to the State Government, annually and at such other intervals, as the Commission may deem fit, reports upon the working of those safeguards.
- c. Inquire into violation of child rights and recommend initiation of proceedings in such cases.
- d. Examine all factors that inhibit the enjoyment of rights of children affected by terrorism, communal violence, riots, natural disasters, domestic violence, HIV/AIDS, trafficking, maltreatment, torture and exploitation, pornography and prostitution and recommend appropriate remedial measures.
- e. Look into the matters relating to children in need of special care and protection including children in distress, marginalized and disadvantaged children, children in conflict with law, juveniles, children without family and children of prisoners and recommend appropriate remedial measures.
- f. Study treaties and other international instruments and undertake periodical review of existing policies, programmes and other activities on child rights and make recommendations for their effective implementation in the best interest of children.
- g. Undertake and promote research in the field of child rights.

- h. Spread child rights literacy among various sections of the society and promote awareness of the safeguards available for protection of these rights through publications, the media, seminars and other available means.
- i. Inspect or cause to be inspected any juvenile custodial home, or any other places of residence or institution meant for children, under the control of the Central Government or any State Government or any other authority, including any institution run by a social organization; where children are detained or lodged for the purpose of treatment, reformation or protection and take up with these authorities for remedial action, if found necessary.
- j. Inquire into complaints and take suo-motu notice of matters relating to:-
 - i. Deprived and violation of Child rights.
 - ii. Non- implementation of laws providing for protection and development of children.
 - iii. Non-compliance of policy decisions, guidelines or instructions aimed at mitigating hardships to and ensuring welfare of the children and to provide relief to such children, or take up the issues arising out of such matters with appropriate authorities.
- k. Such other functions as it may consider necessary for the promotion of child rights and any other matter incidental to the above functions.

Powers relating to Inquiries

As per Section 14(1) of the CPCR Act, 2015

- a. The Commission shall, while inquiring into any matter referred to in clause (j) of sub-section (1) of section 13 have all the powers of a civil court trying suit under the Code of Civil Procedure, 1908 and, in particular, in respect of the following matters namely:
- i. Summoning and enforcing the attendance of any person and examining him on oath.
 - ii. Discovery and production of any document.
 - iii. Receiving evidence on affidavits
 - iv. Requisitioning any public record or copy thereof from any court or officer.
 - v. Issuing commissions for the examination of witnesses or documents.

Steps after Inquiry

As per section 15 of the CPCR Act, 2005. The Commission may take any of the following steps upon the completion of any inquiry held under this Act, namely:-

1. Where the inquiry discloses, the Commission of violation of child rights of a serious nature or contravention of provisions of any law for the time being in force, it may recommend to the concerned Government or authority the initiation of proceedings for prosecution or such other action as the Commission may deem fit against the concerned person or persons.

2. Approach the Supreme Court or the High Court concerned for such directions, orders or writs as the Court may deem necessary.
3. Recommend to the concerned Government or authority for the grant of such interim relief to the victim or the members of his family as the Commission may consider necessary.
Specific Mandate of the Commission as per some important Acts:-
 - a. The Right of Children to free and Compulsory Education Act, 2009.
 - i. Examine and review the safeguards for rights provided by or under this Act and recommend measures for their effective implementation.
 - ii. Inquire into complaints relating to child's right to free and compulsory education;
 - iii. Take necessary steps as provided under section 15 and 24 of the Commission for Protection Rights Act.
 - b. The Commission shall while inquiring into any matters relating to child's right to free and compulsory education under clause (C) of sub-section(1) have the same powers as assigned under section 14 and 24 of the Commissions for Protection of Child Rights.
 - c. Under section 32(3) of the RTE Act, any person aggrieved by the decision of the local authority may prefer an appeal to the Commissions for protection of Child Rights.

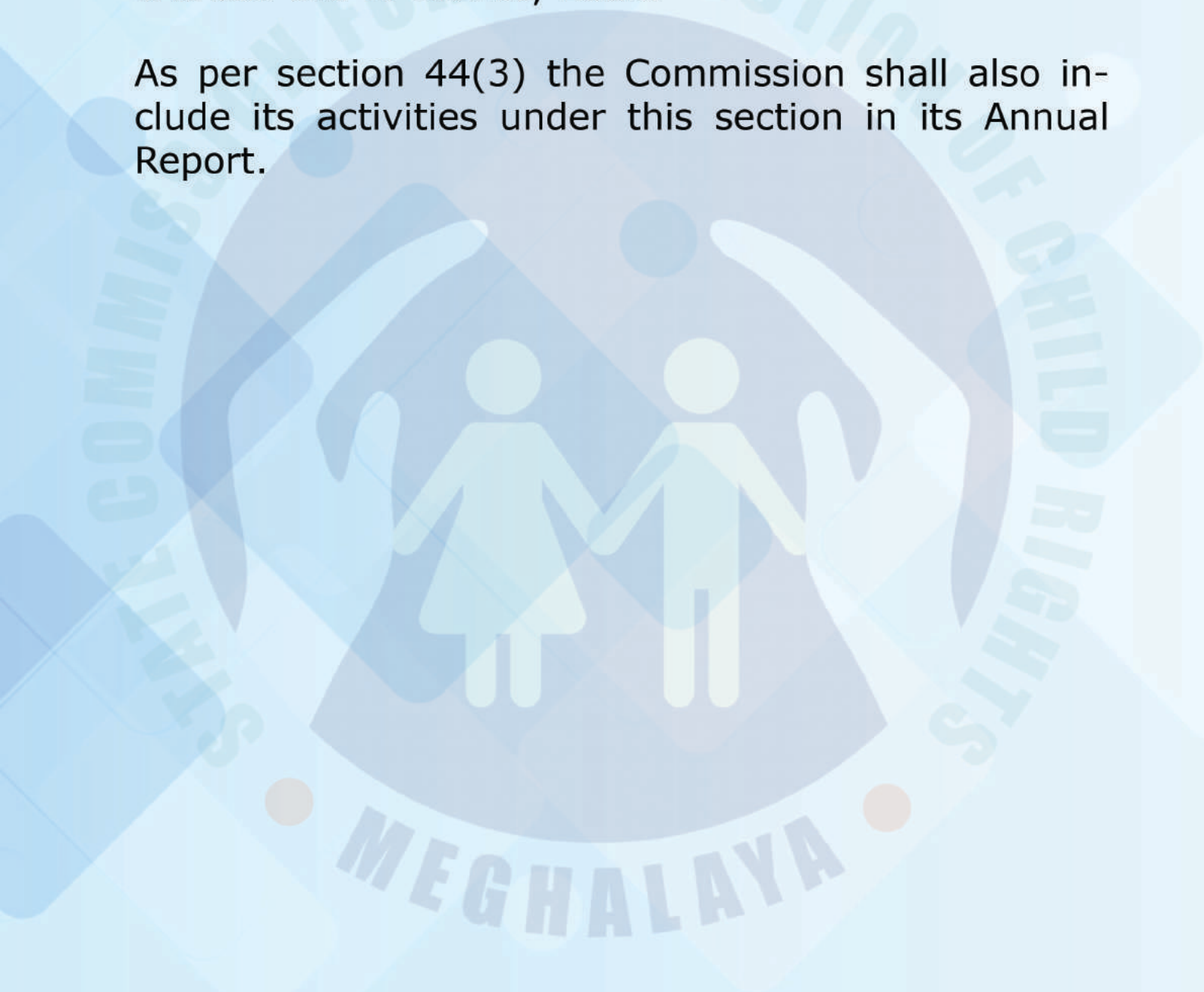
- d. The Juvenile Justice (Care & Protection of Children) Act, 2015.
- e. As per section 109(1) of the JJ Act 2015, the Commission for protection of Child Rights shall in addition to the function assigned to it under the CPCR Act 2005, shall also monitor the implementation of the provisions of the JJ Act in such manner as may be prescribed.
The Commission shall while inquiring into any matter relating to any offence under this Act, shall have the same power as are vested in the Commission under the CPCR Act, 2005.
As per section 109(3) the Commission shall also include its activities under the section in its Annual Report.
- f. The Protection of Children from Sexual Offence Act, 2012.

Section 44-Monitoring of implementation of the POCSO Act.

As per section 44(1) of the POCSO Act, the Commission shall in addition to the functions assigned under the CPCR Act, also monitor the implementation of the provisions of the POCSO Act in such manner as may be prescribed.

As per section 44(2) the Commission shall while inquiring into the matter relating to any offence under this act shall have the same powers as are vested in it under the CPCR Act, 2005.

As per section 44(3) the Commission shall also include its activities under this section in its Annual Report.



NOTIFICATIONS OF THE CHAIRPERSON

The Chairperson was appointed as one of the Member of the New Task Force on the Meghalaya State Policy on Education vide EDN.49/2015/323 dated the 18th June 2018. She had also suggested some recommendations for Primary & Secondary Institutions to be adapted in the State Education Policy.

**Recommendations from the State Commission
for Protection of Child Rights,
Meghalaya for Primary & Secondary Institutions
to be adapted in the State Education Policy.**

1. Safe and secure environment.
2. Infrastructures to include separate toilets/playground to be child-friendly and accessible to PWD's (Person with Disability) also.
3. Inspections of Government schools/Aided Government school and Unaided Government school to be mandatory once in 6 (Six) months. Penalties to be imposed for non-implementation.
4. Child Protection Policy to be implemented in all schools.

5. Complaint Box & information of Childline-1098 to be placed at a prominent place at every school.
6. Corporal punishment must have zero tolerance.
7. Each school must engage Counselors.
8. Promote the incorporation of Child Rights into the school curriculum, teacher's training and training of personnel dealing with children.

The Observations of the Inspections of the CCI's of all the Five Districts of Garo Hills:-

1. Government Run Homes were not well-equipped as per the standard of living of children as per the JJ system. All the premises were rented with congested rooms and high rents.
2. It was observed that till date, no State Inspections were conducted.
3. The Management of Administrative works were found lacking.
4. Mis-appropriation of funds were noticed in the Observation Home (Boys) to which representation has been sent to the Govt. for causing inquiry and taking necessary action.
5. Recommendation was also made for State Inspections, regular training of the staffs and counselors etc, official vehicles for DCPU's and for filling up vacant posts in the Homes.

Inspections of School

Inspection was made in the "Pine Mount" school, Shillong by the Chairperson & one Member, Smti. (Dr) V. Kharmawphlang on the 1st October 2018. On the Inspection conducted in the entire premises, the team observed that the prestigious Government school had failed the students and borders in many counts accordingly after meeting the Principal, a Report was submitted to the Government and the Education Department to take measures in addressing all the pertaining issues with regard to the school and the administration upon receipt of the report, the Education Department submitted on Action-taken Report on all the issues which will be looked into at the earliest. The Commission is still following the case.

REPORT ON J.J. M. NICHOLLES ROY L.P. SCHOOL, SHELLA

Inspections of School

The Chairperson & Member Secretary paid a visit to J.J. M. Nicholes Roy L.P. School, Shella on the 6th August 2018.

On reaching the school premises, it was noticed that cleanliness and lack of space was very poor. The class-rooms were very small, with no proper cooling appliances for example fans and unkempt toilets.

The Mid-day Meal Scheme provided by the SSA has not been implemented, giving reasons of not finding cooks etc. the room of the Mid-day Meal was in a shabby condition with no proper maintenance of utensils, etc.

Class X students are occupying the store-room where bags of rice were piled up, in a very unhygienic conditions. The Authorities concerned had voiced out their difficulties with regard to funds, not being sufficient to run the school, which is a fact that could be seen from the surroundings and class-rooms.

After through examinations of all records, advice was given to maintain all records in separate files and transparency to be maintained.

REPORT ON J.J. M. NICHOLLES ROY L.P. SCHOOL, SHELLA

Advisory to the School:-

1. The School Managing Committee should approach the Department of Education for grants to uplift the school.
2. Children should have safe and secure environment in the class-rooms as well as in the surrounding area of the school.
3. Mid-day Meals should be immediately implemented and measures must be initiated by the school to engage cooks and keep the Mid-day Meal Room in a clean and hygienic manner.
4. Awareness Programmes must be initiated to the children on "Child Rights" and other laws related to children.

NOTIFICATION ORDERS BY THE GOVERNOR

Dated Shillong, the 13th February, 2019.

No.EDN/RTE-24/2019/41 :- In pursuance to the guidelines of Ministry Human Resource Development, Government of India, on the weight of school bags and the health of children it is hereby instructed that all school falling under the Department of Education, Government of Meghalaya to comply with the Government guidelines with immediate effect. The guidelines below may be adhered to:

1. Schools shall not assign homework to student except those recommended by MBOSE/ICSE/CBSE.
2. The Schools shall not assign homework to students of Classes I and II.
3. The weight of school bags for students of Class I and II should not exceed 1.5 kg. The maximum weight of school bags for Classes III to V students shall be 2-3 kg for classes Vi to VII students shall be 4 kg, for classes VIII to IX students shall be 4.5 kg and for class X students shall be 5 kg.
4. Students should not be forced to bring additional books and other materials apart from the prescribed textbooks. Schools should make sure that students carry only such textbooks as indicated in the time-table.
5. The Head of Schools and teachers should frame well – designed time table for each class so that children do not have to carry too many books or notebooks to the school each day.
6. Reading library books and participation in Games, Sports, Art & Culture and other creative and other creative and co –curricular activities for holistic development of students must be encouraged.

This notification will take effect immediately.

MEETINGS CONDUCTED BY SCPCR

1st MEETING	13-04-2018
2nd MEETING	07-12-2018

1. The first meeting of the SCPCR was held on 13th April, 2018 where the Commission welcomed the new Member, Smti. Sume. G.B. Sangma. The Chairperson and members also discussed on the delay of the CPP (Child Protection Policy) which was still pending with Social Welfare Department, and it was felt that this urgent matter should be communicated to the Minister, Social Welfare, Govt., of Meghalaya., Other matters which were taken up were:-
 - a. To discuss on the letter which was sent to DHS (Directorate of Health Services) on setting up of De-addiction centre for youths.
 - b. The other matter was discussed on the policy for regulating of private schools/play schools.
 - c. Discussion was also held on the Education Policy of the State.
 - d. After a thread bare discussion on the Agendas, it was felt and voiced by everyone present in the Meeting to approach the Health and Family Welfare Minister to discuss on the issues relating to setting up of De-addiction Centre for Youths in our State as well as to construct "Pink toilets" built specifically for women to raise awareness on Health and Hygiene Issues. The Commission as a whole decided to meet the Principal Secretary, Education Department to raise the issues concerning the Education Policy. The Commission has also entrusted Dr (Mrs) V. Kharmawphlang to initiate this matter.

Later, on the same day the chairperson met the Social Welfare Minister, Govt. of Meghalaya and apprised him of the delay of the draft of the CPP and was assured that he would look into the matter at the earliest.

2. The Second meeting of the SCPCR was held on 7th December 2018 where an emergency meeting had to be convened by the Chairperson and the two Members from Garo Hills and West Khasi Hills could not attend any meetings due to their personal difficulties. Some matters were taken up:-
 - a. Discussion on the report given by the Commission on Pine Mount School to look into the matter and had asked the Commission to give one month time for making necessary corrections.
 - b. The discussion were also made on the Non-attendance of one Member from West Khasi Hills District and report were suggested to be submitted to the Commissioner and Secretary of Social Welfare and also for inducting more members and full time members.
 - c. Proposal for full-time Member Secretary for the Commission to be sent up to the Government.
 - d. Meeting with all the CWC's to be held on the last week of January 2019 to discuss on the role and functions of the Child Welfare Committee.
 - e. On the Complaint of the Misuse of Midday Meal of the Syad Lyngdoh L. P. School & the Umsning C&RD Block, the Member on the meeting which was held on the 7th December 2018 agreed upon to call for a report from SDEO, Ri-Bhoi District on the action taken by them.

- f. The Chairperson & the Member had discussed on the Inspection of CCI's to be conducted from the month of January 2019 at Ri-Bhoi District and on the month of February 2019 at West Jaintia Hills District. The NGO Run Govt. CCI's in East Khasi Hills will also be visit by the Chairperson & Members of SCPCR.
- g. Probably it was discussed to seek an appointment from the PS of Chief Minister Meghalaya for the 21st December, 2018 as a courtesy from the Chairperson & Member SCPCR.
- h. It was also discussed on the follow-up with the Director of School Education on all the letters addressed to the Department relating to various issues of schools.
- i. Meanwhile, a proposal has also initiated to visit the Home Minister in the coming year to discuss on the setting up of Special Courts, Special Public Prosecutors and creation of more posts of Women Police in the Police Department.
- j. Finally, it was also decided that the Commission will write to the Director of DESEL to organized talks on Child Rights and POCSO Act 2012 to our selected number of schools located in East Khasi Hills Districts in which it will be done in a phase manner.

COMPLAINT HEARING CONDUCTED BY SCPCR

4th September, 2018

Urgent Hearing was conducted by the Chairperson SCPCR, Smti. Meena. Kharkongor, Member SCPCR, Smti. V. Kharmawphlang in the office of the Commission on the Complaint filed by Shri. X (name withheld) for not being able to meet his two minor children by the wife. Summons were issued to both the parties but since the wife did not appear in the Commission on the date fixed, another date was re-fixed and an Interim Order was issued by the Commission for the Father to meet his children on the weekend (Saturday) under the supervision of the O/C of the Police Station concerned.

24th September, 2018

On 24th September, 2018 the same matter was taken up where both the Parties were physically present before the chairperson and one member of the Commission. After much deliberation, both parties mutually agreed to share the custody of the children so as not to deprive the children from both parents and a Mutual Agreement was drawn up, where both the parties voluntarily signed. Case was then disposed off.

COMPLAINT HEARING CONDUCTED BY SCPCR

19th December, 2018

Second Hearing took place on 19.12 2018 on a Complaint filed by Shri. X (Name withheld) against his Wife for abandoning their 10 (Ten) month old child. Both parties were present but since they could not resolve their matter, the infant child was ordered to stay with the father for a week and later the baby was handed over to the Wife by mutual consent. The matter was later transferred to the Meghalaya State Commission for Women as the lady in question wanted Separation from the Husband. Case disposed off with a direction that Parties are at liberty to approach the competent Court.

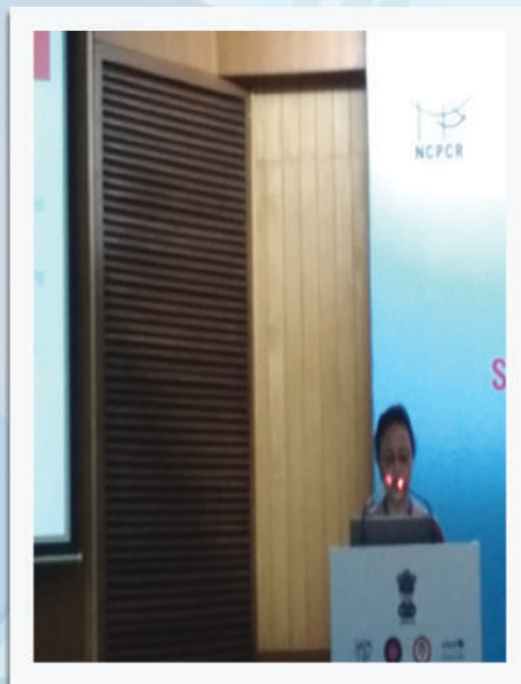

He appreciated that measures were taken to hold such Awareness Programme in the far-flung areas of the District which often remains unattended to, and many crimes especially Sexual Assault crimes of children often turn out to be from such villages where people are not aware of the Law or the Authorities to whom they are to address their grievances. He appreciated the concern and commitment of the National Commission for Protection of Child Rights and the State Commission. During his speech, he spoke of the Parental Responsibilities towards children and how to address the issues by spending more quality time with the children. He stressed on the role of the School's importance in molding children's future and teaching

them good values. While addressing the group of students, the Chief Guest impressed upon them to study well, take responsibilities, respect their fellow students, teachers and parents, at home and at school and to stay away from any bad influences and addiction to drugs which is on the rise now and encouraged them to sow seeds of beauty and Peace in their minds and lives. He concluded his speech with a motivational Quote that is to "SPEAK OUT, REACH OUT and HELP OUT".



The Vote of Thanks was delivered by Miss. Reva Kynjing, District Children Protection Officer. After the Tea- break, the first Session was deliberated by the chairperson, SCPCR as one of the Resource person for the day. Slides on The Prohibition of Child Marriage Act, 2006 was shown to the Participants with explanation on the various sections of the Act, the punishment clauses and the Authorities who are to take action under this particular Act. The effects of Early Marriage and Teen Pregnancy was also explained to the Adolescent group who often fall prey to early marriage in this society.

Parents and elders were also briefed on the ill- effects of early marriages in young girls and boys which not only affect their physical health but also the mental capacity to deal with situations and child births. Villagers who never heard of this Law, paid a lot of attention to this particular topic and raised many healthy questions which were answered. The Resource Person highlighted that it was believed that Child Sexual Abuse occur everywhere, irrespective of Race, Caste, Creed and Religion. In Indian Society, it is often an embarrassment for Parents to talk to children about sexual matters. The Chairperson stressed and encouraged the parents to be more open with their children and interact on the rise of sexual abuse cases among young children and teach them about the Reproductive system of the Human Body. She also addressed the School Heads and Teachers to introduce talks in Schools as part of Awareness amongst the Students and to check on the causes of drop- out from schools.

The Resource Person introduced the session with power point presentation on all the provisions of the child friendly Act, the Authorities who are to deal with it, the Role of the Police, CWC, Magistrate and the POCSO Courts. The Definitions under the POCSO Act was also highlighted through the Power Point Presentation with special emphasis on the Role of the Media in reporting Child Sexual Abuse Cases.

Power point presentation was also shown on the causes of Child Sexual Abuse and how the different stakeholders are to respond to it. The presentation in the local language (KHASI) was also distributed to the participants who were not conversant with the English language. Many queries were raised by the participants and the session was an informative

The third session was taken up by Dr. (Shri) S.D Sumer, D M & H O, Jowai, West Jaintia Hills. He deliberated on the topic of "How to handle Child Sexual Cases" to the different categories of participants. The Doctor cited real- life experiences on some cases brought to the Hospital and how as medical professionals they deal with them. He also gave a lot of information to the group on ways to preserve evidences till the time the victim reaches the hospital for proper DNA collections, etc and that people should not delay in bringing the victims to the nearest hospital or PHC/CHC for immediate treatment. Since the group was a mixed group of many villagers coming from far off villages, he explained to the people that such cases of child sexual abuses which surfaces mostly in remote areas, people should not wait for outside interferences, but seek Police and Medical help at the earliest.

The Superintendent of Police, West Jaintia Hills District, Shri. Vivek Syiem, MPS was also present. He also addressed the participants on the rise of such crimes in West Jaintia Hills and how innocent children become victims for no fault of theirs. He also cited examples of many cases brought before the Police, how they deal with it, etc. The superintendent advised the parents on their Role and Responsibility, how to gain trust of their

children and also to be very vigilant if they notice any strange behavioral changes in their children and to report such changes to the proper Authorities. He assured the people that the Police are there to help the common people and that no one should fear them but come forward for any kind of assistance. He explained the procedure to be followed while reporting any case and also shared the Police Control Number, West Jaintia Hills with the participants. The students were advised to use the social media with caution and to stay away from addiction to drugs.

Right to Education Act (RTE) 2009 was delivered by Shri. P. Sunn, Sub- Inspector of Schools, West Jaintia Hills District. Shri. Sunn focused on the RTE Act, 2009 and said that Education is the "Fundamental Right" of every Child and they should not be denied of this right. He explained that the Government of India has taken the initiative to provide Free and Compulsory Education for all

children between the age of 6 to 14 years and casts obligation on the Government, local Authorities and Parents to provide and ensure admissions, attendance and completion of Elementary Education to all children in the age group of six to fourteen years.

He further explained about the provision of the Sarva Shiksha Abhiyan (SSA) under the Act where the Government provides Funds to construct School Buildings in every village, free Uniforms and free books distributed to the children. Explanation was also given on the provision of the Mid Day Meal (MDM) and the criteria to be followed on the Implementation of the Scheme and that there is penalty under "The Food Security Act" for breach in providing Mid Day Meal by the Schools. Shri. Sunn added that the Government had launched the Rashtriya Madhyamik Shiksha Abhiyan (RMSA) with the aim to provide good quality Education for Secondary Schools which are accessible and affordable to all young children in the age group of 15(Fifteen) to 16(sixteen). He concluded by saying that every village should have a Village Education Committee for the effective Implementation of the RTE Act.



Juvenile Justice (Care and Protection of Children) Act, 2015 delivered by Smti R.D Kynjing, District Child Protection Officer, District Child Protection Unit,

West Jaintia Hills, Jowai. Smt. R. D. Kynjing, District Child Protection Officer, District Child Protection Unit, West Jaintia Hills, Jowai delivered a lecture on Integrated Child Protection Scheme (ICPS).

and briefed that the Integrated Child Protection Scheme is a scheme of the Ministry of Women and Child Development launched throughout the country for the care and protection of children under Eighteen years and its main objective is to provide a Safety Net for children in difficult circumstances. The target group were also highlighted on the scheme which caters to Two Types of Children, Children in Need of Care and Protection (Child Abuse, Child Labour, Missing Child, Abandoned Child, Orphan, Destitute, Etc) and Child in Conflict with Law (Child who commit offences namely, theft, rape, murder etc) and added that presently there is a rise in sexual abuse cases in comparison to previous years. Child Welfare Committee is the competent authority to deal with cases of Child in Need of Care and Protection and Juvenile Justice Board for child in Conflict with Law.

The District Child Protection Officer explained the four basic Rights of a child which are (a) Right to Survival,(b) Right to Development,(c) Right to Protection and(d) Right to Participation.



She further highlighted on the Statutory Support Services which are the Child Welfare Committee, Juvenile Justice Board and Special Juvenile Police Unit and explained on the Role, Functions and Responsibility of Child Welfare Committees and Orders that can be



passed as well as Orders that cannot be passed by the Juvenile Justice Board.

She explained on the procedures for Registration of FIR, Apprehension of child in conflict with law and Final report by the Police. She stressed on the Mandatory Registration, under section 41 of the J.J. Act, 2015 of all Child Care Institutions housing Child in Need of Care and Protection or Child in Conflict with the Law, whether run by the Government or NGOs under the Juvenile Justice Act and the penalty for Non Registration of Child Care Institutions. The process of rehabilitation and reintegration of Child in Need of Care and Protection was also highlighted.

During the Interactive session, many questions were raised on the POCSO Act, the J.J. Act and the RTE Act. The participants who were ignorant on all these Legislations showed Interests and expressed their satisfaction on the Orientation Workshop, requesting more of such programmes to be held in other Villages and Schools. The Programme ended with a Note of Thanks from the Chairperson, SCPCR with a group photograph among the few participants who stayed back for the evening Tea.

11th September 2018	Attended the programme as a Chief Guest to inaugurate the One Day Awareness Programme on Social Networking and Cyber Crime for the Secondary & Higher Secondary Schools in Shillong held at the Soso Tham Auditorium, Shillong.
12th September 2018	One Day Orientation Programme on Child Rights, POCSO Act, RTE Act and JJ Act 2015 organized by the State Commission for Protection of Child Rights and National Commission for Protection of Child Rights which was held at the Jirang Block Conference Hall, Jirang, Ri-Bhoi. The programme started with the welcome address by Smti. B. Passah (Member Secretary, SCPCR), who extended her welcome to the Chief Guest, the Chairperson (SCPCR), Officials of the DCPU, Ri Bhoi and all the Participants, followed by presentation of Bouquets to the Dignitaries by the District Child Protection Unit Officials.

The Chief Guest Smti. F.M. Lakiang (Extra Assistant Commissioner, Ri-Bhoi District) at the onset conveyed the warm regards of the Deputy Commissioner who could not attend the Programme due to unavoidable circumstances by wishing the programme, a Success.

The Chief Guest appreciated the National Commission for Protection of Child rights and the State Commission for taking up sensitive Issues and conducting such Awareness Programmes amongst people, especially those living in the remote areas who are less fortunate to get opportunities to attend to such programmes.

She also highlighted on the rise of Sexual Assault Cases in the district and implored on everyone to take advantage of the Sessions on various Legislations of Children and spread the message in their respective Communities. She further added that if all the people take up collective responsibility in their respective Areas and be vigilant, then only, "We" can prevent atrocities committed upon Children.

The Vote of Thanks was delivered by the District Child Protection Officer, Ri Bhoi District.

The Resource persons for the day were Smti. M. Kharkongor, Chairperson (SCPCR) Meghalaya, Shri. V. Nongbet (DSEO), Ri-Bhoi District, Smti. E. Kalwing (Medical Officer), and Smti. E. Kharpuri(DCPO) Ri-Bhoi District.

Smti. M. Kharkongor , deliberated the First Session on the Topic **"Prohibition of Child Marriage Act, 2006"**. Slides on The Prohibition of Child Marriage Act, 2006 was shown to the Participants with explanation on the various sections of the Act, the punishment clauses and the Authorities who are to take action under this particular Act. The effects of Early Marriage and Teen Pregnancy was also explained to the Adolescent group who often fall prey to early marriage in this society. Parents and elders were also briefed on the ill-effects of early marriages in young girls and boys which not only affect their physical health but also the mental capacity to deal with situations and child births. Villagers who never heard of this Law, paid a lot of attention to this particular topic and raised many healthy questions which were answered. She stated that child/ Early marriages is a very big Issue in the prevalent Society and in order to eradicate it from the society, the Government of India has enacted the "Prohibition of Child Marriage Act, 2006" to make sure that young girls and boys are not married till they reach the age of 18 and 21 years respectively. The Act also prescribes Penalty Clauses for anyone violating the provisions of the Act. She also stated that child marriage has a negative impact on the physical growth, health, mental, emotional development of a child. She concluded by saying that everyone should take child related cases very sensitively and seriously.

In the second session, Smti. M. Kharkongor showed a slide presentation on POCSO Act, 2012. She explained the different forms of sexual abuse and punishments for offences covered in the Act and provisions related to conduct of trial of reported offences.

She further explained about duties of Police as specified in the Act. During the interaction session, queries were also put up by the participants.

The third session, on The Right to Free and Compulsory Education, (RTE)Act, 2009 was presented by Shri. V. Nongbet, DSEO, Nongpoh, Ri Bhoi District. He said that Right to Education is every child's Fundamental Right which provides Free and Compulsory Education for children from the Age group of 6-14 years and also includes Children with Disabilities.



He enlightened the participants on the various important Sections of the RTE Act, wherein Neighborhood Schools are to be opened at a distance of 1 Km and 3 Kms seeing the Child population and Age group of children in the Villages. He also spoke on the services provided by the Anganwadi Centres for providing Free pre- Schooling and Nutrition to the Children under the ICDS Schemes. He concluded by adding that the Act casts obligation on the Government, local Authorities and Parents

to provide and ensure admissions, attendance and completion of Elementary Education of all children in the age group of six to fourteen years.

The fourth session was deliberated by Dr. E. Kalwing, DM &HO, Jirang, Ri Bhoi District, who spoke on how to handle child sexual assault cases. She provided elaborate explanations on the Role of



the Doctors while examining Child Sexual Abuse Cases and also highlighted on the procedures of Examination. The Resource person cited real life incidents and stated that many times Children do not speak out



due to various reasons and one must be very sensitive to the child's need. She further urged the participants to be aware of any warning signs which they notice in Children and approach the Authorities concerned for help.

She also enlightened the Participants about some preventive measures and concluded by suggesting that everyone has a vital role to play in preventing sexual assault. She also addressed the youths during her session, advising them to stay away from any bad influences like Substance addiction, Internet exploration and indulging in early sexual relationships which may destroy their youth and innocence.

The last session was presented by Smti. E. Kharpuri (DCPO), Ri Bhoi District on the Integrated Child Protection Scheme (ICPS) and briefed that the Integrated Child Protection Scheme is a scheme of the Ministry of Women and Child Development launched throughout the country for the care and protection of children under Eighteen years and its main objective is to provide a Safety Net for children in difficult circumstances.



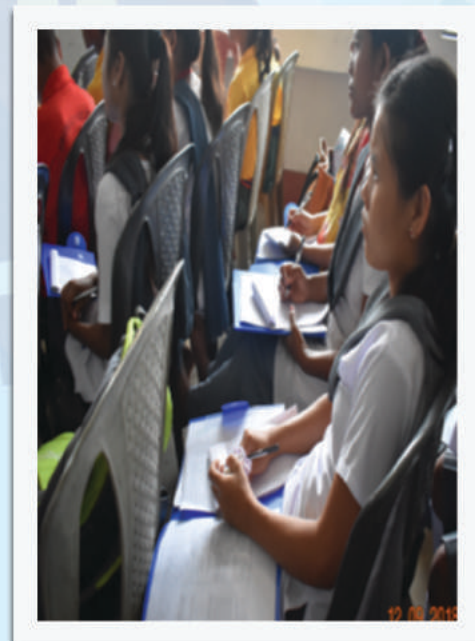
The target group were also highlighted on the scheme which caters to Two Types of Children, Children in Need of Care and Protection (Child Abuse, Child Labour, Missing Child, Abandoned Child, Orphan, Destitute, Etc) and Child in Conflict with Law (Child who commit offences namely, theft, rape, murder etc) She stated that the Government adopted the Act keeping in view the child's Right to Survival, Development, Protection and Participation. She also stressed on the important Fundamental principles and Juvenile Justice System and further explained the importance of protecting child victim's identity and to report to police station or concerned authorities if any such cases arise.

She highlighted on the Statutory Support Services which are the Child Welfare Committee, Juvenile Justice Board and Special Juvenile Police Unit and explained on the Role, Functions and Responsibility of Child Welfare Committees. She also informed that under the J. J. Act, 2015, all Child Care Institutions housing Children in Need of Care and Protection or Children in Conflict with the Law, whether run by the Government or NGOs under the Juvenile Justice system are Mandated to Register the Homes, under Section 41 of the J.J. Act, failing which the said Homes shall be closed down with huge Penalties which shall be imposed upon them.

While concluding her topic, an animated film was shown to the participants on the **"GOOD TOUCH and BAD TOUCH"** to teach children as to how they can respond to potential dangers.

Towards the end of the programme, participants expressed their happiness and thanked the organizers for organizing the Programme in their Area which was first of it's kind in Ji-rang, Ri Bhoi District.

14th September 2018

One Day Orientation Programme on Child Rights, POCSO Act, RTE Act and JJ Act 2015 organized by the State Commission for Protection of Child Rights and National Commission for Protection of Child Rights which was held at the **Community Hall , Khliehriat West, East Jaintia Hills, Khliehriat.**



The Welcome Address was delivered by Smti. M. Kharkongor, Chairperson, SCPCR who extended her warm Welcome to the Chief Guest, other Dignitaries, Medical Health Officers, Police Officers, Heads of Institutions, Headmen of the different Villages, NGOs and Officials of different Homes including Students. In her Welcome Address, Smti. M. Kharkongor gave an overview of the purpose of the Workshop, appreciated the help and support of the National Commission for Protection of Child Rights (NCPCR) for being able to conduct such important programmes all over the State and briefly spoke on the Role and Functions of the Commission.

The Chief Guest, the Honorable Deputy Commissioner, East Jaintia Hills District in his Inaugural Speech expressed his Happiness and lauded the efforts of the Commissions, both at the Centre and the State for taking initiatives to hold programmes relating to Legislations of Children, which he said "**WAS THE NEED OF THE HOUR**".



He pointed out that this particular district where Migrant Population is largely concentrated, Sexual Abuse Cases happen very often and Children are mostly the soft targets. He implored that as stakeholders, it is the duty and responsibility of every individual to reach out and prevent children from falling prey to any kind of violence in the Society. He concluded by adding that the District Administration is always there to give assistance of any nature and that people are free to approach his Office for any kind of assistance, especially related to children. He also requested all the Participants to make use of the Workshop and gain more knowledge and insight on the various Laws relating to Children. The Vote of Thanks was offered by Shri. T. Kyndiah, DCPO, Khliehriat.

PROGRAMME OF THE SCPCR 2018-2019

The First session was on the "**THE PROHIBITION OF CHILD MARRIAGE ACT, 2006**" was taken up by Smti. M. Kharkongor.



At the very outset, the concept of *CHILD MARRIAGE AND EARLY MARRIAGE* was explained by the Resource person. In Meghalaya, the practice of Solemnization is not prevalent as there are no forced Child Marriages but the rampant practice of Early Marriages between the age of 14/ 15/ 16 /17 are seen in the State, especially in the rural areas. The causes and Dangers of Early Marriages were explained through Slide Presentation. Thereafter the Act on "Prohibition of Child Marriage" was shown to the group. Important provisions with regard to the jurisdiction of the Courts, the role and Responsibilities of the Prohibition Officers were explained as per the Act with emphasis on the Punishment Clauses.

The second session was deliberated on the **PROTECTION OF CHILDREN FROM SEXUAL OFFENCES (POCSO) ACT, 2012**. The Resource Person through the Slide Presentation, explained about the Definitions of Penetrative Sexual Assault, Aggravated Penetrative Sexual Assault, Sexual Assault, Sexual Harassment, Using Child for Pornographic use, Abetment and Attempt to

commit the offence, the different penal sections and also the Authorities who are to deal with this Act. The Role of the Police and the Media was also pointed out and the provisions in case of violation of Section 19 & 23 was highlighted to the participants. An Appeal was made by the Resource Person not to hide such Offences but to reach out to the Authorities for help and support and to report the incidents as early as possible in order to punish the Offenders and give help and support to the survivor and her/ her family.

The Third session was on " Right to Education Act, 2009" taken by Smt. P. Dkhar, Sub-divisional School Education Officer, East Jaintia Hills District.



The Resource person in her opening statement, narrated how the R.T.E Act, came into effect on 1st of April, 2010 under Article 21 A of the Constitution of India. The title of the RTE Act incorporates the words '**free and compulsory**'.

'**Free education**' means that no child, other than a child who has been admitted by his or her parents to a school which is not supported by the appropriate Government, shall be liable to pay any kind of fee or charges or expenses which may prevent him or her from pursuing and completing elementary education. '**Compulsory education**' casts an obligation on the appropriate Government and local authorities to provide and ensure admission, attendance and completion of elementary education by all children in the 6-14 age group.

PROGRAMME OF THE SCPCR 2018-2019

The RTE Act provides for the:

- Right of children to free and compulsory education till completion of elementary education in a neighborhood school.
- It makes provisions for a child to be admitted to an age appropriate class.
- It specifies the duties and responsibilities of appropriate Governments, local authority and parents in providing free and compulsory education, and sharing of financial and other responsibilities between the Central and State Governments.
- It provides for appointment of appropriately trained teachers, i.e. teachers with the requisite entry and academic qualifications.
- It prohibits:-
 - (a) Physical punishment and mental harassment;
 - (b) Screening procedures for admission of children;
 - (c) Capitation fee;
 - (d) Private tuition by teachers and
 - (e) Running of schools without recognition.

The resource person above concluded with an appeal to all to ensure that all children avail the benefit of the RTE Act in Letter and Spirit.

The fourth session was taken up by Dr.(Smti) N.P. Suchiang, DM&HO, East Jaintia Hills who briefly introduced herself and went on to say that as Medical Professional, a great Responsibility lies on their shoulder when any Child who has been sexually assaulted is brought before them.



She also stated that in cases where the Family prefer to take their children to the nearest hospitals, response is "Key to the Child's immediate well-being and long term recovery". The evidence collected in the course of medical examination of victims of sexual assault is core in most investigation in POCSO cases. A thorough explanation was given as per the Guidelines on the Do's and Don'ts while examining Children, methods of examinations,



Consent, detailed history of the child, evidence collection, treatment, documentation and follow-up. She also demonstrated the emergency Medical Kit which is to be kept at every Hospitals/ PHCs and CHCs for accurate evidence collection.

The Resource person spoke very passionately on her life experiences of children, when brought before her. She implored to the Male Medical Professionals who were also present in the programme, not to refuse examination in case of Emergencies when critical child injuries are brought to their facility, but to treat them as mandated under the Guidelines of The Ministry of Health & Family Welfare, Govt. of India on Medico-legal Cases.



The session ended after a detailed Interaction where the participants took interest to ask many questions of which until now, most of them were ignorant.

PROGRAMME OF THE SCPCR 2018-2019

The last session was on the **"Child Rights" & "Juvenile Justice"** (Care & Protection for Children) Act, 2015 Act taken by the Shri. T. Kyndiah, District Child Protection Officer, East Jaintia Hills.



Shri Kyndiah started by saying that, the Constitution of India has envisaged a healthy society for the children of which shall be free from abuse and exploitation. The fact remains that majority of our children are deprived of their childhood due to numerous reasons. Although the Constitution of India and the UN Convention on the Rights of the Child- 1989 have reiterated on the protection of the dignity and life of children, still child rights violation is on the rise. Everyday cases of child rights violation is being reported in many forms. It is high time that all the stakeholders under the banner of Child Protection Services realize their role and duties towards the cause of ensuring protection to our children.

Children are considered to be the most vulnerable group in the society. They are dependent, have the least power, and have less control over their own lives. Among children there are some who are marginalized and neglected than others because of their socio- economic cultural circumstances.

PROGRAMME OF THE SCPCR 2018-2019

These children are considered as Children in need of Care and Protection under Juvenile Justice (Care & Protection of Children) Act, 2015. They are found mostly in different situations like:

1. In families at risk.
2. On the street
3. In institution The contributing factors for the children to be vulnerable and becoming at risk are because of the following reasons:
 - o Orphan, abandoned and surrendered children
 - o Street children
 - o Working children/child labourer
 - o Abused children
 - o Children who are victim of commercial sexual exploitation and trafficking.
 - o Children engaged in substance abuse.
 - o Children in families at risk
 - o Differently-able children
 - o Mentally ill children
 - o HIV/AIDS- infected /affected children

Awareness, sensitization and capacity building is one of the powerful intervention to discuss child rights violation and also a better platform as most of the time such issues are being swiped under the carpet and considered as un-important.

Juvenile Justice System is reformatory in nature and not punitive oriented and based on this spirit Juvenile Justice (Care & Protection for Children) Act, 2015 Act was enacted to bring changes in the system and also to see to it, that no children below the age of 18 years is abused by any means from all level.

Therefore to achieve the purpose JJ ACT mandated under provision of Section 106 that every districts in the State shall have a District Child Protection Unit to take up matters relating to Children in Need of Care and Protection and Juvenile in Conflict with Law with a view to ensure the effective implementation of the Act including the establishment and maintenance of Homes, notification of competent authorities in relations to these children and their rehabilitation and coordination with various official and non-official agencies concerned.

JJ Act also mandated on the constitution of three important statutory Bodies at the district level to exclusively deals with different target groups of children accordingly as per the provisions of the said Act.

The said authorities are as follows:-

- 1. Juvenile Justice Board**
- 2. Child welfare Committee**
- 3. Special Juvenile Police Unit**

Similarly, JJ Act has made it mandatory for the establishment of different Child Care Institutions for long term and short term care of children. The Act mandates that all institution running Child Care Institutions whether run by NGO's or Government shall have to register under JJ Act and failure of which will be viewed seriously according to the provisions of the Act.

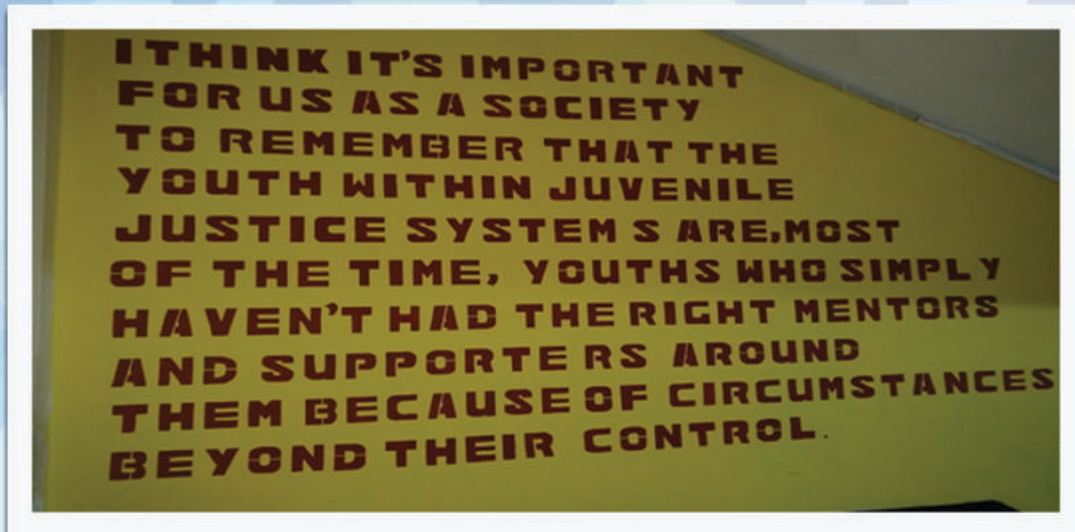
As stated earlier JJ ACT is a Reformatory Act in nature and not Punitive, therefore it is the duty of each and every stakeholder to fulfill its provisions and implement it in Letter and Spirit for building a better world for our children. The Programme ended on a very satisfactory note, followed by tea and photo session of the few remaining participants.

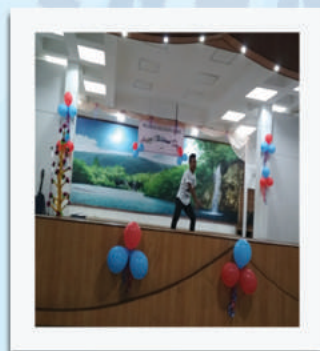

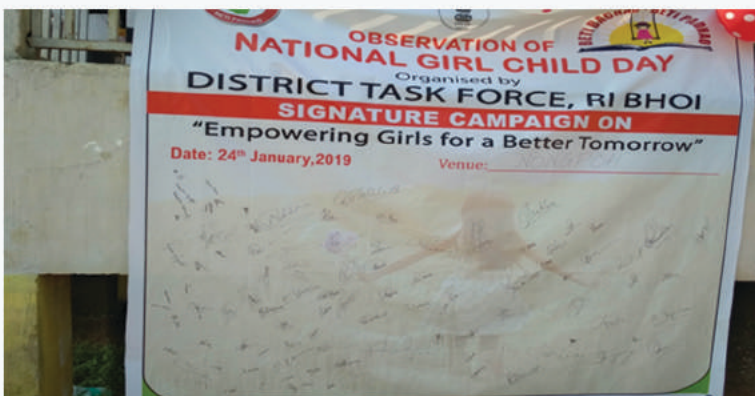
