MEGHALAYA STATE COMMISSION FOR PROTECTION OF CHILD RIGHTS (MSCPCR)

BACKGROUND

With the aim of effectively addressing the issue of protection of Child Rights in Meghalaya, the State Commission for Protection of Child Rights was set up. The Commission comprise of a Chairperson and six members including two women representatives.

The Government of Meghalaya, Social Welfare Department, vide Notification No. SW(S) 112/2009/236 dated, Shillong the 28th February, 2014 under section 4, sub-section (3) of the Commission for Protection of Child Rights Act, 2005(4th of 2006), the Governor of Meghalaya appointed Smti. Meena Kharkongor as Chairperson, State Commission for Protection of Child Rights for a period of 3(three) years with immediate effect.

The Chairperson joined the Commission on 11th March, 2014 and the office was opened on the 23rd May, 2014 at Nongshiliang, Nongthymmai, Shillong with a staff strength consisting of only the Chairperson, one peon and a chowkidar. The Commission functioned from the above address till February, 2015 and thereafter shifted its office to Lower Lachumiere, Shillong.

After the first term of the State Commission for Protection of Child Rights expired, Smt. Meena Kharkongor was reappointed as Chairperson vide Notification No. SW(S) 112/2009/447 dated Shillong, the 26th July, 2017 for a further period of 3 (Three) years when the period ended. During the interim arrangement Smt C Kharkongor IAS, Secretary Social Welfare was given the additional duty and appointed as Chairperson vide Notification No. SW(S) 112/2009/572.

Thereafter vide Notification No SW(S) 112/2009/693 dated 9th September 2020, the Governor of Meghalaya appointed Smt Iamonlang M Syiem as Chairperson, State Commission for Protection of Child Rights for a period of 3(three) years with immediate effect.

There are six members who were notified and joined the Commission vide Notification No. SW(S) 112/2009/694 dated 9th September 2020, namely:

FUNCTIONS AND POWERS

FUNCTIONS OF THE COMMISSION:

Section 13 (1) of the Commission for Protection of Child Rights Act, 2005 lays down the functions of the Commission as follows:

- 1. Examine and review the safeguards provided by or under any law for the time being in force for the protection of child rights and recommend measures for their effective implementation.
- 2. Present to the State Government, annually and at such other intervals, as the Commission may deem fit, reports upon the working of those safeguards.
- 3. Inquire into violation of child rights and recommend initiation of proceedings in such cases.
- 4. Examine all factors that inhibits the enjoyment of rights of children affected by terrorism, communal violence, riots, natural disasters, domestic violence, HIV/AIDS, trafficking, maltreatment, torture and exploitation, pornography and prostitution and recommend appropriate remedial measures.
- 5. Look into the matters relating to children in need of special care and protection including children in distress, marginalized and disadvantaged children, children in conflict with law, juveniles, children without family and children of prisoners and recommend appropriate remedial measures.
- 6. Study treaties and other international instruments and undertake periodical review of existing policies, programmes and other activities on child rights and make recommendations for their effective implementation in the best interest of children.
- 7. Undertake and promote research in the field of child rights.
- 8. Spread child rights literacy among various sections of the society and promote awareness of the safeguards available for protection of these rights through publications, the media, seminars and other available means.
- 9. Inspect or cause to be inspected any juvenile custodial home, or any other places of residence or institution meant for children, under the control of the Central Government or any State Government or any other authority, including any institution run by a social organization; where children are detained or lodged for the purpose of treatment, reformation or protection and take up with these authorities for remedial action, if found necessary.
- 10. Inquire into complaints and take sou-motu notice of matters relating to:-
- 11. Deprived and violation of Child rights.
 - i. Non-implementation of laws providing for protection and development of children.
 - ii. Non-compliance of policy decisions, guidelines or instructions aimed at mitigating hardships to and ensuring welfare of the children and to provide relief to such children, or take up the issues arising out of such matters with appropriate authorities.
- 12. Such other functions as it may consider necessary for the promotion of child rights and any other matter incidental to the above functions.



POWERS RELATING TO INQUIRIES

As per Section 14(1) of the CPCR Act, 2015

- a. The Commission shall, while inquiring into any matter referred to in clause (j) of sub-section
 (1) of section 13 have all the powers of a civil court trying suit under the Code of Civil Procedure, 1908 and, in particular, in respect of the following matters namely:
- i. Summoning and enforcing the attendance of any person and examining him on oath.
- ii. Discovery and production of any document.
- iii. Receiving evidence on affidavits
- iv. Requisitioning any public record or copy thereof from any court or officer.
- v. Issuing commissions for the examination of witnesses or documents.

STEPS AFTER INQUIRY

As per section 15 of the CPCR Act, 2005. The Commission may take any of the following steps upon the completion of any inquiry held under this Act, namely:

- 1. Where the inquiry discloses, the Commission of violation of child rights of a serious nature or contravention of provisions of any law for the time being in force, it may recommend to the concerned Government or authority the initiation of proceedings for prosecution or such other action as the Commission may deem fit against the concerned person or persons.
- 2. Approach the Supreme Court or the High Court concerned for such directions, orders or writs as the Court may deem necessary.
- 3. Recommend to the concerned Government or authority for the grant of such interim relief to the victim or the members of his family as the Commission may consider necessary.

SPECIFIC MANDATE OF THE COMMISSION AS PER SOME IMPORTANT ACTS:

- a. The Right of Children to free and Compulsory Education Act, 2009.
- i. Examine and review the safeguards for rights provided by or under this Act and recommend measures for their effective implementation.
- ii. Inquire into complaints relating to child's right to free and compulsory education; and compulsory education.
- iii. Take necessary steps as provided under section 15 and 24 of the Commission for Protection Rights Act.
- b. The Commission shall while inquiring into any matters relating to child's right to free and compulsory education under clause (C) of sub-section(1) have the same powers as assigned under section 14 and 24 of the Commissions for Protection of Child Rights.
- c. Under section 32(3) of the RTE Act, any person aggrieved by the decision of the local authority may prefer an appeal to the Commissions for protection of Child Rights.
- d. The Juvenile Justice (Care & Protection of Children) Act, 2015.
- e. As per section 109(1) of the JJ Act 2015, the Commission for protection of Child Rights shall in addition to the function assigned to it under the CPCR Act 2005, shall also monitor the



implementation of the provisions of the JJ Act in such manner as may be prescribed. The Commission shall while inquiring into any matter relating to any offence under this Act, shall have the same power as are vested in the Communication under the CPCR Act, 2005. As per section 109(3) the Commission shall also include its activities under the section in its Annual Report.

f. The Protection of Children from Sexual Offence Act, 2012: Section 44-Monitoring of implementation of the POCSO Act.: As per section 44(1) of the POCSO Act, the Commission shall in addition to the functions assigned under the CPCR Act, also monitor the implementation of the provisions of the POCSO Act in such manner as may be prescribed. As per section 44(2) the Commission shall while inquiring into the matter relating to any offence under this act shall have the same powers as are vested in it under the CPCR Act, 2005.

As per section 44(3), the Commission shall also include its activities under this section in its Annual Report.





THE COMMISSION FOR PROTECTION OF CHILD RIGHTS

The Bill for establishing the Commissions exclusively for protecting rights of children was first introduced in Parliament in 2003. Thereafter, it was referred to the Department – related Parliamentary Standing Committee on Human Resources Development. The Committee submitted its 165th Report in 2005 on the Commission for Protection of Child Rights Bill, 2005. The Bill was debated in Parliament and passed in 2005. It received the President's assent on 20th January, 2006.

The Commission of Protection of Child Rights Act, 2005 (CPCR ACT) provides for the constitution of a National Commission and State Commission for protection of Child Rights. It also provides for the establishment of Children's Court for providing speedy trail of offences against children or of violation of Child Rights.

The National Commission for Protection of Child Rights (NCPCR) being a statutory body constituted under section 3 of the Commission for Protection of Child Rights (CPCR) Act 2005 (4 of 2006) is responsible for ensuring that all children enjoy their rights provided under different legislations. Specifically, NCPCR has been mandated with the responsibility of monitoring the implementation of legislations relating to child rights such as Juvenile Justice (Care and Protection of Children) Act 2015(u/s 109); POCSO Act 2012 (u/s 44) and RTE Act 2009 (u/s 31). The Commission further ensures that all laws, programmes, administrative policies, recommendations, campaigns, advisories etc, should be in complete alignment with the child rights perspective as enshrined in the United Nations Convention on the Rights of the Children (UNCRC).

The Meghalaya State Commission for Protection of Child Rights was notified and established on 28th February, 2014. The Meghalaya State Commission for Protection of Child Rights from its inception has been engaged in upholding the spirit of the Constitution by protecting and promoting the Rights of Children and many important steps have been taken up by the Commission for the Protection of Rights of the children in the State to ensure that children have a protective Child- friendly environment.

The Mandate of the Commission is to "PROTECT, PROMOTE and MONITOR" Child Rights in any form. The Constitution of India stipulates Rights of Children. Article 15 (3) allows the State makes special provisions for Children, Article 21 A recognizes the Right to Free and Compulsory Education for Children and Article 24 prohibits employment of children below the age of 14 years in factories, mines or any hazardous employment. Further the Constitution also imposes certain duties upon the State in the form of Directive Principles of State Policy, which are Article 39 (c) and (f) and Article 45. It also imposes a fundamental duty under Article 51 (k) upon parents to provide opportunities for Education to their children.

The Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 (No.14 of 2013) provides protection against sexual harassment of women at the workplace and for prevention and redressal of complaints of sexual harassment and matters connected therewith or incidental thereto.

As per the Chapter –II of the said Act, every employer of a workplace by an order in writing, has to constitute a committee to be known as the "Internal Complaints Committee".

PROCEEDING OF THE MEETING HELD ON 3RD MARCH, 2021 AT THE OFFICE OF THE STATE COMMISSION FOR PROTECTION OF CHILD RIGHTS (SCPCR), MEGHALAYA, SHILLONG

This is the first formal meeting between the new Chairperson Meghalaya State Commission for Protection for Child Rights Smti I. M. Syiem and the District Child Protection Officer (DCPO) from six (6) Districts. Also present were the State Child Protection Society Programme Manager (SCPS) and Programme Manager, State Adoption Resource Agency (SARA).

The pertinent issues/ challenges that were raised at the meeting were also as follows:

I. POCSO Report:

- 1. Uniformity in submission of the POCSO Report.
- 2. Delay in submission of POCSO Report from the Police and Courts.

II. JJ ACT:

- 1. ICPS (CPS) Guidelines are outdated which makes them not at par with the JJ Act.
- 2. Reporting problems.

III. Other Issues Discussed:

- 1. The non availability of DDRC (District Disability Resource Centre) in East Jaintia Hills District makes it difficult for assessment of children. It is problematic to get the disability certificate as the children will have to travel a long distance to get the services of another DDRC in another District.
- 2. Non availability of psychiatrists for preliminary assessment of heinous crime done by children between ages 16-18 years.
- 3. Follow up procedure should be available after adoption.
- 4. Idea of developing a Northeast Portal for adoption process in order for NE States to get a chance to adopt a child from the NE itself.
- 5. Clarifying doubts and difficulties regarding Management Information System (MIS).
- 6. Need for identifying POCSO hotspots: Awareness and Sensitization Programmes are needed.
- 7. Need for Capacity building Workshops and Management Information System training for officers in the field.
- 8. Follow up letter sent by the Programme Manager State Child Protection Society (SCPS) regarding POCSO information to be printed on the back page of Meghalaya Board of School Education text books for awareness.

RESOLUTION:

- The Commission will follow up on what has been discussed and do the needful.
- It was decided that a review meeting for all District Officers be held twice a year.


CELEBRATION OF POSHAN MAAH

The District Child Protection Unit, East Khasi Hills District took a great initiative to organize a one day plantation program in the Juvenile Home, Mawkasiang. This is an important step of encouraging the maintenance of a kitchen garden at the Child Care Institution and to grow vegetables that are organic, fresh and healthy. The Chief Guest for the program was Smt. I. M Syiem, Chairperson Meghalaya SCPCR, she was accompanied by Dr. Iwamon W. J. Laloo Associate Professor, Department of Education, Martin Luther Christian University.



POSHAN MAAH ABHIYAAN 2020 AT THE CHILDRENS HOME GIRLS, KHLIEHRIAT

The Office of Children's Home Girls, Khliehriat observed Poshan Maah on 16th September 2020 by conducting a small sensitization programme. The programme started with a statement from the superintendent about Poshan Maah that it was launched by our Prime Minister Shri. Narendra Modi on 8th March 2018. It was also the International Women's Day celebration.

The Paramedical staff continued the sensitization by stating that Poshan Maah is a programme to address the problem of malnutrition among women and young children. Every year Poshan Maah is celebrated all over the country under POSHAN ABHIYAAN, launch in 2018. The aim behind the celebration of Poshan Maah is to encourage *Jan Bhagidaari* - in order to ensure health and nutrition for everyone. The target of this programme is to bring down the stunting in children from 8.4% to 25% by 2025. The focus is due to COVID-19 which may increase severe acute malnourishment and burden across the country.

Children were explained about the importance of each food that is provided for them and their benefit or nutritional value For example, the different components of food being provided are:

- 1. Pumpkin: pumpkin has a good amount of potassium and beta-carotene, which is a carotenoid that converts to vitamin A. It also contains some minerals including calcium and magnesium, as well as vitamins E, C and B.
- 2. Yam: packed with nutrition. Yams are rich in vitamins, minerals, and fiber which may enhance brain function. Eating yams may boost your brain, may ease symptoms of menopause, may have cancer fighting properties, may reduce inflammation, may improve blood sugar control.
- 3. Egg: rich sources of selenium. vitamin D, B6, and minerals such as zinc, iron and copper. Eggs yolks contain more calories and fat than the whites. They are a source of fat soluble vitamins A, D, E and K and lecithin, the compound that enables emulsification in recipes such as hollandaise or mayonnaise.
- 4. Maida: contain many nutrients such as fiber, vitamins, iron, magnesium, phosphorus, manganese and selenium.
- 5. Horse gram: horse gram seed contains carbohydrate, protein, dietary fiber, fat, calcium, phosphorus, iron and calories as well as vitamin like thiamine, riboflavin and niacin.
- 6. Carrot: carrots are a particularly good source of beta carotene, fiber, vitamin K I, Potassium and antioxidants. They also has a number of health benefits.
- 7. Tomatoes: a tomato is a nutrient-dense super food that offers benefit to a range of bodily systems. Its nutritional content supports healthy skin, weight loss and heart health.
- 8. Gooseberries: gooseberries are rich in antioxidants such a phytonutrients and vitamins E and C which may help protect your brain and fight aging, type two diabetes, cancer and heart disease

The programme concluded with a vote of thanks form the superintendent and refreshments that followed.



REPORT ON THE TWO DAY STATE LEVEL CONSULTATION ON THE 26TH AND 27TH OF MARCH, 2021 AT SHILLONG, ORGANIZED BY NCPCR IN COLLABORATION WITH MSCPCR

"Available facilities and status of New Born and Pediatric Care in Shillong - analyzing the gap and Steps to Improve Quality of Care"

OBSERVATIONS/ GAPS/ ISSUES

Health is not an individual issue/problem but a societal one.

- 1. Lack of Pediatric Units.
- 2. No uniform distribution of Specialists especially in the rural areas.
- 3. Lack of infrastructure and transportation issues.
- 4. Junior Doctors should be trained before being sent to rural or remote areas
- 5. Infant and maternal mortality (increase during pandemic).
- 6. Services like supplementary nutrition and SUGGESTIONS: maternal (pre-natal, post-natal) health does not often reach the people who most need it.
- 7. The expectations from grassroots

service providers like Anganwadis and ASHAs in terms of 24 hour service is not commensurate with their honorarium/ payment. The role of the Anganwadis and ASHAs is an important one linking communities and ensuring government schemes and safeguards reach the most vulnerable and needy section of the society.

8. An issue that was also raised relates to the shortage of manpower (trained staff in health units).

1. A key factor is convergence of all departments in addressing the most glaring issues (transport, health, education and awareness, etc).





- 2. Remuneration of the grassroots, field workers like Anganwadis and ASHAs should be enhanced, commensurate to their dedicated services. Many of them have to facilitate help from their own meager earnings. If they are able to augment their pay by engaging in other income generating activities, while sincerely committed to their duties would ease their financial burdens.
- 3. Systems of accountability and transparency should be re-examined and revamped to ensure schemes and services are not lost in paperwork and transactional deal 6. More stress on the 1000 days.
- between government representatives and community leadership. This strong recommendation for strong monitoring agencies (social audit) between policies and implementation are needed through external agencies.
- 4. In an increasingly cashless society to ensure that monetary assistance should be directly transferred to the beneficiaries' account.
 - 5. More awareness programs needed especially for mothers.

'Issue of Heavy Weight of School Bags

Dr Susan M. Nongsiej (DERT Faculty) and Dr B. M Mylliem (DERT Faculty) gave a presentation relating to the 2020 Policy on School Bags and its impact. Some of the issues discussed were:

- 1. Reduction of the weight of Schools bags which should not exceed more than 10% of the body weight of a child. However not all States and Educational Institutions have fully complied with the Guidelines.
- 2. Suggestions to replace loose sheets instead of multiple homework notebooks.
- 3. Schools should encourage sharing of heavy textbooks among children. However there is the Covid constraint to consider.
- 4. Some structural requirements be put in place like construction of school lockers etc. Not all Institutions may be able to comply because of financial constraints.

Dr K.K Choudhury (Director & Regional Officer, CBSE Guwahati, Assam)gave a perspective of the burden of learning that our Educational Systems impose on our children including the weight of schoolbags. He reminded the participants that we diminish the joy of living for children which is also their right. "Let this be the contribution of this generation to the next - to be burdened less".

In her session Dr D. Pde (Pediatrician) highlighted the effects of the modern Education System and its effect on deteriorating mental health of children. The grevious injuries that can be caused by heavy school bags in the form of spinal deformities, stunted growth, posture, and effect on the circulation system and neck and head pain was further elaborated. In the ensuing discussions, it was also pointed out that children suffer emotional pain and face psychological distress because of the stress of too much homework, memorizing for exams and decreasing self esteem because of failure and other learning issues.

Dr. B. Tron (Assistant Professor CTE (PGT)) pointed out that these issues relating to children and learning had been identified by



the Government of India as early as 1992. Some of the pertinent issues she highlighted were:

- School texts are often written by Professors which is way above the learning level of children and often unnecessary.
- 2. Too many subjects to learn and memorize.
- 3. Some topics like EVS does not require heavy textbooks when only some chapters are taught. The implication is that that some textbooks are promoted for commercial reasons.
- 4. The question of timetable is an important one. Often maximum subjects are crammed into a timetable which implies more homework since every teacher will allot work because they also have a target to complete. The burden is both on children and teachers as well to achieve maximum marks in the exam oriented system. This is a major cause of stress for everyone including parents.

The common outcome/suggestions that

emerged from the collective discussions were:

- Best practices should be followed like redesigning Timetable, checking weights of schoolbags regularly, using loose sheets instead of heavy notebooks. Heavy textbooks including dictionaries to be kept at the School premises. No textbooks on minor subjects.
- 2. Awareness should be given to all stakeholders (teachers, students, parents).
- 3. Free Counseling, medical checkups for children to avail.
- 4. No board exams for lower classes.
- 5. More importantly, Notification by the State Government on weight and health of children for institutions to strictly comply with Guidelines. Old policies to be reexamined and new policies needed for changes in the Learning and Evaluation systems which are more child centric, and keeping their physical, mental and Social well being in mind.
