As per section 109(3) the Commission shall also include its activities under the section in its Annual Report.

f. The protection of Children from Sexual Offence Act, 2012.

Section 44-Monitoring of implementation of the POCSO Act.

As per section 44(1) of the POCSO Act, the Commission shall in addition to the functions assigned under the CPCR Act, also monitor the implementation of the provisions of the POCSO Act in such manner as may be prescribed.

As per section 44(2) the Commission shall while inquiring into the matter relating to any offence under this act shall have the same powers as are vested in it under the CPCR Act, 2005.

As per section 44(3) the Commission shall also include its activities under this section in its Annual Report.

NO.EDN/RTE-218/2011/ 101- In pursuance to the recommendation of the National Commission for Protection of Child Rights (NCPCR), Government of India, and in compliance to Section 29 of the Right of Children to Free and Compulsory Education Act, 2009, the following directions shall be adhered by all institutions.

- 1. All Schools shall strictly follow the prescribed curriculum (Syllabus, textbooks) and evaluation procedure in elementary classes as prescribed by the State Academic Authority.
- 2. No child shall be discriminated or harassed or neglected by the school for carrying books published/prescribed by the Academic Authority (SCERT/DERT) resulting to mental or physical suffering. Any action taken on the child, may attract the provision of Juvinile Justice Act, 2015.
- 3. The school shall display this notification in the school's website and notice board. A copy shall be circulated and disseminated among parents for information.

Any non compliance on the above may prima facie be treated as violation of RTE Act, 2009.

Inspections of School

Mawryngkneng RMSA School

During the Awareness Programmes conducted in schools, The Commission came across the dilapidated condition of the Mawryngkneng RMSA School and the students studying there were not having toilet facilities.

Therefore being concerned, meeting was immediately initiated by the State Commission for Protection of Child Rights calling upon the Block development officer (BDO) of the concerned Block and the Authority concerned from the Education Department.

Meeting took place on the 13th September 2019 in the chamber of the Block Development Officer which was chaired by the Chairperson, State Commission for Protection of Child Rights.

The Chair apprised the members present of the sorry state of affairs of the Mawrynkneng RMSA Secondary School, wherein there are no provisions for toilet for the children studying the school. She also informed that the electrical connection and water supply in the school is also non functional which has caused immense hardship to the students and the faculty members of the School.

Shri. R. Wahlang, MCS BDO. Mawrynkneng C&RD Block informed the members present that the Block office will move the State Coordinator, Swacch Bharat Mission for providing funds for construction of toilets in the school. Further, he also informed that he will take up the matter with the VEC Mawrynkneng to explore the possibility of constructing the toilets under MGNREGA.

Shri. Andrew Warjri, S/O and Deputy State Director, DSEL and SSA informed the members present that proposal has been made to the Government of India by the State Government for placement of funds for carrying out repair in the next financial year 2020-2021.

After a threadbare discussion a joint inspection by the BDO, Mawrynkneng Block and the Deputy State Project Director, DSEL and SSA, Government of Meghalaya of the school premises will be carried out on the 17th of September, 2019 at 1:00 PM to ascertain the existing condition of the school infrastructure.

Joint Report on the Site Visit at Mawryngkneng RMSA Secondary School. East Khasi Hills

The Joint Inspection was carried out on the request of the Chairperson, SCPCR, in response to the report on the dilapidating condition of the newly constructed RMSA Schools in Mawryngkneng Block.

Shri. R. Wahlang, MCS, Block Development Officer, accompanied the field visit and shared valuable inputs on Swaach Bharat Mission and exploring the possibilities of providing additional support on school fencing, toilets facilities and Capacity Building on Swaach Bharat to children of the school.

The Block Development Officer requested the school authorities to report to his office on any issues pertaining to school safety, additional support etc, for onward submission to the Deputy Commissioner, East Khasi Hills.

During the visit on the construction of Mawryngkneng RMSA Secondary School building accompany by Civil Work Coordinator, Head Mistress & Head Master of the respective schools both RMSA and Govt LPS/UPS on the 17th September, 2019. The following issues were observed:-

- The school building is completed except Paint Work (Action to be taken by PWD (B).
- 2. False ceiling need urgent repair in the Staff Office (Action to be taken by PWD (B).
- Side drain of the school building need to be constructed in order to avoid over flowing of water into the classroom.
- 4. RMSA Toilet shall be constructed within the Govt LPS Septic Tank.
- 5. Main Gate & Fencing need to be constructed at the earliest. (Proposal alongwith land documents to be submitted to Block Development Officer)

It was also observed during the visit of the school building that due to the lack of initiative of school's representatives for conducting social work etc, the school campus is an eyesore with plastic and paper scattering around the campus and the toilet blocks are unattended.

The Block Development Officer, Mawrygkneng C&RD, adviced the school's representatives to submit proposal on immediate requirement for further recommendation to Competent Authority.

The Bill for establishing the Commissions exclusively for protecting rights of children was first introduced in Parliament in 2003. Thereafter, it was referred to the Department – related Parliamentary Standing Committee on Human Resources Development. The Committee submitted its 165th Report in 2005 on the Commission for Protection of Child Rights Bill, 2005. The Bill was debated in Parliament and passed in 2005. It received the President's assent on 20th January, 2006.

The Commission of Protection of Child Rights Act, 2005 (CPCR ACT) provides for the constitution of a National Commission and State Commission for protection of Child Rights. It also provides for the establishment of Children's Court for providing speedy trail of offences against children or of violation of Child Rights. The Meghalaya State Commission for Protection of Child Rights was notified and established on 28th February, 2014.

Nehru Memorial Secondary School, Umsning.

On a verbal complaint by one parent whose child is studying at the Nehru Memorial Secondary School, Umsning, Ri-Bhoi District on the unhygienic condition of the school toilets, The Chairperson and Member, Dr (Smti.) V. Kharmawphlang made a surprise visit to the school on 12th September 2019.

On physical verification of the school and the girl toilets, it was found to be very dirty, dark with no drainage and this has brought in concern for the health of the children using the same.

The principal has been advised to maintain the toilet and surroundings of the school and letter was addressed to the DSEO Nongpoh, Ri-Bhoi to follow-up which was done accordingly. Now the toilets are in better condition.

HC takes up delay in release of compensation for rape victims <u>Bv Our Reporter</u>

SHILLONG: The High Court of Meghalaya on Thursday took up the plight of rape victims, who are yet to receive compensation under the approved package.

Earlier on Wednesday, a letter from Meena Kharkongor, the Chairperson of Meghalaya State Commission for Protection of Child Rights in this regard was placed before the Chief Justice of High Court Meghalaya and it was registered as a PIL.

According to the letter, despite the interim compensation of Rs 2 lakh as awarded by the Special Court (POCSO) in Shillong on August 5 this year, the state government has not made any payment to the families of a child victim.

"It appears on perusal of the report that the child victim, a minor girl of 3 ½ years old, has to undergo medical treatment outside the state which, if provided with the compensation, will go a long way in her treatment. Since the state government despite the interim compensation, as ordered, has not yet made any payment, the matter being extremely serious needs to be noticed on the judicial side, the joint registrar (judicial) said. During the hearing on the matter, the division bench comprising Chief Justice Ajay Kumar Mittal and Justice HS Thankhiew, issued notice to Advocate General who accepted it on behalf of the state government. The advocate general produced a copy of the order of November 11 last year passed by the division bench wherein Rs 50 lakh under the victim

The court issued notice to member secretary, MSLSA to be present in the court on Friday.

State govt releases over Rs 51L for victims of rape <u>By Our Reporter</u>

SHILLONG: The state government has released over Rs 51 lakh to Meghalaya State Legal Service Authority (MSL SA) to provide compensation to person under the victim compensation scheme.

The compensation is mostly claimed by victims of rape.

The division bench comprising Chief Justice Ajay Kumar Mittal and Justice HS Thangkhiew took up the matter after the issue was raised by the child rights commission Meena Kharkongor since a minor rape victim urgently required the compensation

Earlier, a letter was addressed by the chairperson, State Commission for Protection of Child Rights (SCPCR), to Registrar General of the court informing that despite the award of interim compensation of Rs 2 lakh by the Special Court (POCSO) on September 5, the state go vernment had not released the payment to the family of the child.

The letter was then registered as Public Interest Litigation and was taken up on September 12. Later, the case was adjourned to September 13 and during the hearing, the Advocate General Amit Kumar had produce a cheque for Rs 2 lakh drawn in favour of SCPCR, for payment of compensation to the victim child.

On Thurs day, it was informed by the Member Secretary, MSLA that Rs 51, 14,506 has been paid by the state government to enable MSLSA to release compensation to different persons entitled under the victim compensation scheme. Following this, the petition was disposed of.

The Mandate of the Commission is to "PROTECT, PROMOTE and MONITOR" Child Rights in any form. The Constitution of India stipulates Rights of Children. Article 15 (3) allows the State makes special provisions for Children, Article 21 A recognizes the Right to Free and Compulsory Education for Children and Article 24 prohibits employment of children below the age of 14 years in factories, mines or any hazardous employment. Further the Constitution also imposes certain duties upon the State in the form of Directive Principles of State Policy, which are Article 39 (c) and (f) and Article 45. It also imposes a fundamental duty under Article 51 (k) upon parents to provide opportunities for Education to their children.

The Meghalaya State Commission for Protection of Child Rights from its inception has been engaged in upholding the spirit of the Constitution by protecting and promoting the Rights of Children and many important steps have been taken up by the Commission for the Protection of Rights of the children in the State to ensure that children have a protective Child- friendly environment.

He had expressed that there were verbal complaints against the said teacher in the past by the co-teacher but nothing was submitted to him in writing. With regard to the physical assault on the students, he said that he has not received any complaints from the students.

It was suggested that in future any complaints addressed to the principal was to made in writing.

Regular meeting to be held with the school management and two students representatives to be in the SMC, hence forth.

Later all the Teachers (Primary to the High Secondary) were assembled in the hall where all the members stressed on the role of the teacher in the 21st century. Dr (Smti) Kharmawphlang spoke at length on the changing role of the teacher. Punishment for corporal punishment was also read out by Smti I. Rapthap, State Child Protection Society. 



FUNCTIONS AND POWERS OF THE COMMISSION

Functions of the Commission

Section 13 (1) of the Commission for Protection of Child Rights Act, 2005 lays down the functions of the Commission as follows:

- **a.** Examine and review the safeguards provided by or under any law for the time being in force for the protection of child rights and recommend measures for their effective implementation.
- **b.** Present to the State Government, annually and at such other intervals, as the Commission may deem fit, reports upon the working of those safeguards.
- **c.** Inquire into violation of child rights and recommend initiation of proceedings in such cases.
- **d.** Examine all factors that inhibits the enjoyment of rights of children affected by terrorism, communal violence, riots, natural disasters, domestic violence, HIV/AIDS, trafficking, maltreatment, torture and exploitation, pornography and prostitution and recommend appropriate remedial measures.
- e. Look into the matters relating to children in need of special care and protection including children in distress, marginalized and disadvantaged children, children in conflict with law, juveniles, children without family and children of prisoners and recommend appropriate remedial measures.
- **f.** Study treaties and other international instruments and undertake periodical review of existing policies, programmes and other activities on child rights and make recommendations for their effective implementation in the best interest of children.
- **g.** Undertake and promote research in the field of child rights.
- **h.** Spread child rights literacy among various sections of the society and promote awareness of the safeguards available for protection of these rights through publications, the media, seminars and other available means.
- i. Inspect or cause to be inspected any juvenile custodial home, or any other places of residence or institution meant for children, under the control of the Central Government or any State Government or any other authority, including any institution run by a social organization; where children are detained or lodged for the purpose of treatment, reformation or protection and take up with these authorities for remedial action, if found necessary.

- j. Inquire into complaints and take suo-motu notice of matters relating to:
 - i. Deprived and violation of Child rights.
 - ii. Non- implementation of laws providing for protection and development of children.
 - iii. Non-compliance of policy decisions, guidelines or instructions aimed at mitigating hardships to and ensuring welfare of the children and to provide relief to such children, or take up the issues arising out of such matters with appropriate authorities.
- **k.** Such other functions as it may consider necessary for the promotion of child rights and any other matter incidental to the above functions.

Powers relating to Inquiries

As per Section 14(1) of the CPCR Act, 2015

- a) The Commission shall, while inquiring into any matter referred to in clause (j) of sub-section (1) of section 13 have all the powers of a civil court trying suit under the Code of Civil Procedure, 1908 and, in particular, in respect of the following matters namely:
 - i. Summoning and enforcing the attendance of any person and examining him on oath.
 - ii. Discovery and production of any document.
 - iii. Receiving evidence on affidavits
 - **iv.** Requisitioning any public record or copy thereof from any court or officer.
 - v. Issuing commissions for the examination of witnesses or documents.

Steps after Inquiry

As per section 15 of the CPCR Act, 2005. The Commission may take any of the following steps upon the completion of any inquiry held under this Act, namely:

- 1. Where the inquiry discloses, the Commission of violation of child rights of a serious nature or contravention of provisions of any law for the time being in force, it may recommend to the concerned Government or authority the initiation of proceedings for prosecution or such other action as the Commission may deem fit against the concerned person or persons.
- 2. Approach the Supreme Court or the High Court concerned for such directions, orders or writs as the Court may deem necessary.
- 3. Recommend to the concerned Government or authority for the grant of such interim relief to the victim or the members of his family as the Commission may consider necessary. Specific Mandate of the Commission as per some important Acts:
- **a.** The Right of Children to free and Compulsory Education Act, 2009.
 - **i.** Examine and review the safeguards for rights provided by or under this Act and recommend measures for their effective implementation.
