MEGHALAYA STATE COMMISSION FOR PROTECTION OF CHILD RIGHTS





From the Chairperson

Protecting the Rights and safety of children from all walks of life, cutting across age, gender, ethnic, class affiliations or belief systems has been a challenging task in the best of times. The Pandemic lockdown and post-lockdown situation has presented more challenges and different circumstances that call for new kinds of responses, both by the Commission and Society as a whole. As a statutory body set up by the Commission Act of 2005, the Meghalaya State Commission for the protection of Child Rights established in 2014 is mandated to monitor implementation of the POCSO Act 2012, the RTE Act 2009, and the Juvenile Justice (Care and Protection of Children) Act 2015. The Commission is also guided and strengthened by policies, laws and other such mechanisms in its mandate to ensure the protection of the Rights of Children in the 'best interest of the Child'.

Children, during the pandemic lockdown and post lockdown, are increasingly vulnerable to all kinds of dangers and issues from mental health to online learning, to social isolation and especially to sexual predators, including online grooming. Online schooling has necessitated the use of mobile phones by even the very young. The danger of accessing inappropriate content through the internet and the negative impact of social media has been compounded by the fact that parents and guardians are not all conversant and proficient in the use of this medium. Hence they cannot wisely guide, monitor or advise their wards to be safe in virtual reality. There have been cases that come to the Commission where children have been referred for counseling because of their addiction to social media, which have affected their physical, social, mental health and their learning processes.

Regarding POCSO, there have been more reporting of POCSO cases especially from areas where there is greater awareness through programmes in the schools and communities.

In 2020, because of the pandemic, the Commission launched its YouTube Channel to reach out virtually to more children, families and districts with specific topics such personal Safety Education (safe and unsafe touch etc), mental health issues and Child Rights issues.

One of the essential need to understand Child Rights and their violation, is to have consistent and reliable data. The Commission receives Reports (especially on POCSO) from the DCPU (District Child Protection Units), the Police and the POCSO judges. The Commission has also requested all child rights organizations as well as One Stop Centres to provide regular data on Child Abuse cases (CSA). The work of digitizing all the data since the start of the Commission i.e. 2014 is almost complete. To expedite the process, we are in the process of creating a portal (through NIC) to upload such data from the key sources. It is hoped that this data (to be published) will be accessed by all stakeholders, including policy makers.

In order to build up a strong research database and generate more data relating to various child rights issues, the Commission is collaborating with several institutes and agencies to achieve this goal. We hope that the data generated from such ventures will provide greater clarity on Child Rights violation in the State.

Knowledge sharing and awareness programs especially on the Rights of children, on POCSO, substance abuse, personal safety among other topics are a significant activity of the Commission. There is an urgent need to intensify such programs in the schools but there are financial constraints to consider. Many of the programs have been in collaboration with child rights organizations, agencies and institutions. We acknowledge their key role in our endeavor. Cases come to the Commission relating to children whose parents have separated or relating to physical abuse in schools and such kind. It was difficult to conduct such Hearings physically during the pandemic so some Hearings had to be conducted and recorded online. However Hearings are now regularly conducted face to face.

The Commission is only one of the entities engaged proactively in strengthening and addressing the vulnerable gaps in the protective system in the State.

I take this opportunity to acknowledge the role and assistance of all stakeholders. First of all, I'm grateful to the Government of Meghalaya for its unwavering support and assistance to the work of the Commission. Special acknowledgement and appreciation to Social Welfare Department, Government of Meghalaya without which the Commission would not able to fulfil its duties. Special commendation goes to all the District Child Protection Officers and the DCPU for their dedication and prompt response in any situation they are called for and their assistance and support to the Commission in its functions and activities.

It is my privilege to acknowledge and thank the Meghalaya Police Department for their dedicated work, the Education Department, the Health Department, the Commission for Persons with Disabilities, the Labour Department, Department of Information and Public Relations and other departments for their assistance and co-operation for every help at various times, on issues faced by the Commission.

We are indebted to all the Rangbah Shnongs, Community leaders, Civil Societies, NGO's and Youth groups who have extended their help and reached out to the Commission and collaborated with us in creating awareness on child right issues. The Commission owes a great deal to the Press and Media for their timely information and help on issues that concern children.

My gratitude to Member Secretary Shri L. Lyngdoh for always being there for the Commission, for his support and advice and for his encouragement and assistance.

I greatly appreciate the Members of the Commission whom we often meet online when we cannot meet physically because of distance, for their support and advice. The Staff have been excellent in their dedication and service in the function of the Commission and I greatly appreciate their commitment and hard work.

This Report is also placed on behalf of all children, every child whose rights have been violated and deprived of a good life and safe childhood. It is our responsibility to respond and fill in the gaps in our endeavour to protect children and enable them to live a whole and healthy life.

MEGHALAYA STATE COMMISSION FOR PROTECTION OF CHILD RIGHTS (MSCPCR)



BACKGROUND

With the aim of effectively addressing the issue of protection of Child Rights in Meghalaya, the State Commission for Protection of Child Rights was established. The Commission comprise of a Chairperson and six members including two women representatives.

The Meghalaya State Commission for Protection of Child Rights Rules 2013 was notified vide Govt. of Meghalaya Notification No. SW(S) 112/2009/170 dated 10th July, 2013.

Subsequently, the Government of Meghalaya, Social Welfare Department, vide Notification No. SW(S) 112/2009/236 dated, Shillong the 28th February, 2014 appointed Smti. Meena Kharkongor as Chairperson, State Commission for Protection of Child Rights. The Chairperson joined the Commission on 11th March, 2014 and the office was inaugurated on the 23rd May, 2014.

Smt. Meena Kharkongor tenure was renewed vide Notification No. SW(S) 112/2009/447 dated Shillong, the 26th July, 2017. When Smt M Kharkongor's term ended, an interim arrangement was made in which Smt C Kharkongor IAS, Secretary Social Welfare was given the additional duty and appointed as Chairperson vide Notification No. SW(S) 112/2009/572.

The Government of Meghalaya vide Notification No SW(S) 112/2009/693 dated 9th September 2020, appointed Smt Iamonlang M Syiem as Chairperson, State Commission for Protection of Child Rights who has been continuing in this post till date.

The Commission comprises of the Chairperson, Member Secretary and six members. There are six members who were notified and joined the Commission vide Notification No. SW(S) 112/2009/694 dated 9th September 2020, namely:

FUNCTIONS AND POWERS OF THE COMMISSION

FUNCTIONS OF THE COMMISSION :

Section 13 (1) of the Commission for Protection of Child Rights Act, 2005 lays down the functions of the Commission as follows:

- 1. Examine and review the safeguards provided by or under any law for the time being in force for the protection of child rights and recommend measures for their effective implementation.
- 2. Present to the State Government, annually and at such other intervals, as the Commission may deem fit, reports upon the working of those safeguards.
- 3. Inquire into violation of child rights and recommend initiation of proceedings in such cases.
- 4. Examine all factors that inhibits the enjoyment of rights of children affected by terrorism, communal violence, riots, natural disasters, domestic violence, HIV/AIDS, trafficking, maltreatment, torture and exploitation, pornography and prostitution and recommend appropriate remedial measures.
- 5. Look into the matters relating to children in need of special care and protection including children in distress, marginalized and disadvantaged children, children in conflict with law, juveniles, children without family and children of prisoners and recommend appropriate remedial measures.
- 6. Study treaties and other international instruments and undertake periodical review of existing policies, programmes and other activities on child rights and make recommendations for their effective implementation in the best interest of children.
- 7. Undertake and promote research in the field of child rights.
- 8. Spread child rights literacy among various sections of the society and promote awareness of the safeguards available for protection of these rights through publications, the media, seminars and other available means.
- 9. Inspect or cause to be inspected any juvenile custodial home, or any other places of residence or institution meant for children, under the control of the Central Government or any State Government or any other authority, including any institution run by a social organization; where children are detained or lodged for the purpose of treatment, reformation or protection and take up with these authorities for remedial action, if found necessary.
- 10. Inquire into complaints and take sou-motu notice of matters relating to:-
- 11. Deprived and violation of Child rights.
 - i. Non- implementation of laws providing for protection and development of children.
 - ii. Non-compliance of policy decisions, guidelines or instructions aimed at mitigating hardships to and ensuring welfare of the children and to provide relief to such children, or take up the issues arising out of such matters with appropriate authorities.

12. Such other functions as it may consider necessary for the promotion of child rights and any other matter incidental to the above functions.

POWERS RELATING TO INQUIRIES

As per Section 14(1) of the CPCR Act, 2015

- a. The Commission shall, while inquiring into any matter referred to in clause (j) of subsection (1) of section 13 have all the powers of a civil court trying suit under the Code of Civil Procedure, 1908 and, in particular, in respect of the following matters namely:
- i. Summoning and enforcing the attendance of any person and examining him on oath.
- ii. Discovery and production of any document.
- iii. Receiving evidence on affidavits
- iv. Requisitioning any public record or copy thereof from any court or officer.
- v. Issuing commissions for the examination of witnesses or documents.

STEPS AFTER INQUIRY

As per section 15 of the CPCR Act, 2005, the Commission may take any of the following steps upon the completion of any inquiry held under this Act, namely:

- Where the inquiry discloses, the Commission of violation of child rights of a serious nature or contravention of provisions of any law for the time being in force, it may recommend to the concerned Government or authority the initiation of proceedings for prosecution or such other action as the Commission may deem fit against the concerned person or persons.
- 2. Approach the Supreme Court or the High Court concerned for such directions, orders or writs as the Court may deem necessary.
- 3. Recommend to the concerned Government or authority for the grant of such interim relief to the victim or the members of his family as the Commission may consider necessary.

SPECIFIC MANDATE OF THE COMMISSION AS PER SOME IMPORTANT ACTS:

- a. The Right of Children to free and Compulsory Education Act, 2009.
- i. Examine and review the safeguards for rights provided by or under this Act and recommend measures for their effective implementation.
- ii. Inquire into complaints relating to child's right to free and compulsory education; and compulsory education.
- iii. Take necessary steps as provided under section 15 and 24 of the Commission for Protection Rights Act.
- iv. The Commission shall while inquiring into any matters relating to child's right to free and compulsory education under clause (C) of sub-section(1) have the same powers as assigned under section 14 and 24 of the Commissions for Protection of Child Rights.
- v. Under section 32(3) of the RTE Act, any person aggrieved by the decision of the local authority may prefer an appeal to the Commissions for protection of Child Rights.

- b. The Juvenile Justice (Care & Protection of Children) Act, 2015.
- As per section 109(1) of the JJ Act 2015, the Commission for protection of Child Rights shall in addition to the function assigned to it under the CPCR Act 2005, shall also monitor the implementation of the provisions of the JJ Act in such manner as may be prescribed. The Commission shall while inquiring into any matter relating to any offence under this Act, shall have the same power as are vested in the Communication under the CPCR Act, 2005. As per section 109(3) the Commission shall also include its activities under the section in its Annual Report.
- c. The Protection of Children from Sexual Offence Act, 2012 : Section 44-Monitoring of implementation of the POCSO Act. : As per section 44(1) of the POCSO Act, the Commission shall in addition to the functions assigned under the CPCR Act, also monitor the implementation of the provisions of the POCSO Act in such manner as may be prescribed. As per section 44(2) the Commission shall while inquiring into the matter relating to any offence under this act shall have the same powers as are vested in it under the CPCR Act, 2005.

As per section 44(3), the Commission shall also include its activities under this section in its Annual Report.

THE COMMISSION FOR PROTECTION OF CHILD RIGHTS



The Bill for establishing the Commissions exclusively for protecting rights of children was first introduced in Parliament in 2003. Thereafter, it was referred to the Department related Parliamentary Standing Committee on Human Resources Development. The Committee submitted its 165th Report in 2005 on the Commission for Protection of Child Rights Bill, 2005. The Bill was debated in Parliament and passed in 2005. It received the President's assent on 20th January, 2006.


The Commission of Protection of Child Rights Act, 2005 (CPCR ACT) provides for the constitution of a National Commission and State Commission for protection of Child Rights. It also provides for the establishment of Children's Court for providing speedy trail of offences against children or of violation of Child Rights.


The National Commission for Protection of Child Rights (NCPCR) being a statutory body constituted under section 3 of the Commission for Protection of Child Rights (CPCR) Act 2005 (4 of 2006) is responsible for ensuring that all children enjoy their rights provided under different legislations. Specifically , NCPCR has been mandated with the responsibility of monitoring the implementation of legislations relating to child rights such as Juvenile Justice (Care and Protection of Children) Act 2015(u/s 109); POCSO Act 2012 (u/s 44) and RTE Act 2009 (u/s 31). The Commission further ensures that all laws, programmes , administrative policies, recommendations , campaigns , advisories etc, should be in complete alignment with the child rights perspective as enshrined in the United Nations Convention on the Rights of the Children (UNCRC).

The Meghalaya State Commission for Protection of Child Rights was notified and established on 28th February, 2014. The Meghalaya State Commission for Protection of Child Rights from its inception has been engaged in upholding the spirit of the Constitution by protecting and promoting the Rights of Children and many important steps have been taken up by the Commission for the Protection of Rights of the children in the State to ensure that children have a protective Child- friendly environment.

The Mandate of the Commission is to "PROTECT, PROMOTE and MONITOR" Child Rights in any form. The Constitution of India stipulates Rights of Children. Article 15 (3) allows the State to make special provisions for Children, Article 21 A recognizes the Right to Free and Compulsory Education for Children and Article 24 prohibits employment of children below the age of 14 years in factories, mines or any hazardous employment. Further the Constitution also imposes certain duties upon the State in the form of Directive Principles of State Policy, which are Article 39 (c) and (f) and Article 45. It also imposes a fundamental duty under Article 51 (k) upon parents to provide opportunities for Education to their children. 9


CASES RECEIVED BY THE COMMISSION






POCSO CASES IN THE STATE IN 2022

2021-2023 | MSCPCR Annual Report

In compliance with the direction and instruction of National Commission for Protection of Child Right (NCPCR) through the Chairperson of Meghalaya State Commission for Protection of Child Right (SCPCR) to observe the celebration of Rashtriya Poshan Maah (National Nutrition Month) in the whole month of September, 2022 in the Child Care Institutions, activities and programmes were carried out for the children as per guidelines laid down by the Commissions. Poshan Maah is being celebrated as part of the POSHAN Abhiyaan, the Central Government's flagship programme which aims to improve nutritional outcomes for children under 6 years of age, pregnant women and lactating mothers. As part of the 5th Rashtriya Poshan Maah, the ministry plans to involve in the Gram Panchayats as Poshan Panchayats with the key focus on Women's Health and Children's Education.

Ministry of Women and Child Development is celebrating the 5th Rashtriya Poshan Maah 2022 across the nation from 1st September till 30th September. Rashtriya Poshan Maah serves as a platform to bring focus to the discourse of nutrition and good health. In the 5th Rashtriya Poshan Maah, the aim is to convert Jan Andolan into Jan Bhagidari to fulfil the Prime Minister's vision of a Suposhit Bharat. The Central Theme of Poshan Maah 2022 is "Mahila aur Swasthya" and "Bacha aur Shiksha". The Child Care Institutions and various Shelter Homes (Boys , Girls and Special Needs) have taken this opportunity to celebrate this month of Poshan Maah, by involving the children in different activities. The following activities were conducted across these homes:

- Health assessment : To check their height and weight and also maintaining the growth chart of each individual as per World Health Organisation growth chart.
- 2. Awareness on general cleanliness : related to the importance of personal hygiene like trimming of nails and washing hands before and after coming from the toilet and before preparing food. The children were also taught to clean their wardrobe, fold clothes and arranging them in the wardrobe.
- **3. Role play**: To explain concepts of waste management such as proper disposal of waste in the house/ roads/ while driving/ travelling and usage of Dustbins.
- **4. Discussion on COVID**: Awareness, brainstorming and discussion on the protocols and prevention of covid-19 ,to

wear mask in public ,to cover mouth while coughing and sneezing, to wash hands after coughing and to use hand sanitizer when necessary.

- **5. Teaching concepts of gardening**: to explain the planting and consumption of fresh vegetables from the kitchen garden of the Child Care Institutions and Homes.
- **6. De-worming**: De-worming medication Albendazole 400 mg has been provided to the children.
- 7. Promotion of local cuisine: The Cook and the children also prepared locally available traditional food regularly. The children also taught how to wash the vegetables properly before cooking them.
- 8. The children were also taught other concepts like table manners and personal care.



STATE LEVEL SENSITIZATION CUM ORIENTATION PROGRAM ON PARIKSHA PARV 4.0 ORGANIZED BY NATIONAL COMMISSION FOR PROTECTION OF CHILD RIGHTS IN COLLABORATION WITH MEGHALAYA STATE COMMISSION FOR PROTECTION OF CHILD RIGHTS

Pariksha Parv 4.0 program was held on the 26th of April 2022 at State Convention Centre, Shillong, Meghalaya. The Chief Guest for the Program was Shri Metbah Lyngdoh, Hon'ble Speaker, Legislative Assembly Government of Meghalaya. The Guest of Honour was Shri Kyrmen Shylla, Hon'ble Social Welfare Minister, Government of Meghalaya.

Registration and light Refreshment was from 9.30 to 10.30 The program commenced at 10.30 with a welcome song by a child artist and cultural dances performed by the North East Zone Cultural Centre (NEZZCC) comprising of the three Tribes of Meghalaya : the Khasis, Garos and Jaiñtias.

This was followed by felicitation of the dignitaries on the dais and lighting of the lamp at 11 a.m.

At 11.10, Ms Iamon M. Syiem, Chairperson, SCPCR, Meghalaya welcomed the dignitaries and the gathering. She briefly highlighted the history/origin and importance of Child rights emphasizing on the right to Education,

36 development and enjoyment of life. Miss Syiem spoke on the need to manage stress

while we try to overcome life's problems and also to take these tests as a step to higher levels that help mould us. This is especially important for students who deal with stress of exams and expectations. She also encouraged the young students to accept the reality of Exams which is similar to the tests of life which confronts everybody, young or old. She also addressed teachers to come up with unique strategies to lessen the stress of exams for the students. She exhorted the students to work towards their dreams, realize their potential and soar to higher levels of achievements.

The welcome speech was followed by the distribution of the 'Exam Warrior' book authored by the Hon'ble Prime Minister of India Shri Narendra Modi- whichwas facilitated by Shri. Sanjay Kumar Mishra from The Asia Foundation, to selected students from the CCI's and the students of various schools. These books were also given out to all participants at the program.

At 11.30, Guest of Honour, Shri Kyrmen Shylla, Hon'ble Minister, Social Welfare Department, Government of Meghalaya addressed the

gathering. He highlighted the need to disseminate information on stress management students to especially when it comes to exam related stress - to use the different information and communication materials available at NCPCR website and the Pariksha Parv platforms.

At 11.40, the Chief Guest, Shri Metbah Lyngdoh, Hon'ble Speaker, Meghalaya Legislative Assembly presented his speech. In his speech Shri. Lyngdoh expressed his appreciation for holding such programs, adding whichever that programs children attends, it indicates the presence of life and hope. He expressed his thanks to the Hon'ble Prime Minister of India Shri. Narendra Modi for initiating such an important programme.

While citing relevant examples, he mentioned the student teacher ratio. He also asked for such programmes to reach out to rural areas as the challenges are different for the rural students, as also the quality of education is different. Although there are students who may match up with urban children but the wider majority find difficulties to cope especially during and after the pandemic. Village wise school campaigns and community mobilizations can help. The exampackage should be made more attractive and enjoyable. To the students he exhorted to maintain a healthy lifestyle in order to be physically and psychologically prepared for exam related stress management.

At 11.55, Smt. Rupali Banerjee Singh, Member Secretary, NCPCR, graciously rounded the Inaugural section with a vote of thanks to the Hon'ble Guests and the participants.

At 12.00, the Chief Guest and Guest of Honour took leave of the program and were accompanied by NCPCR and SCPCR members for refreshment during which some more issues were raised with the Ministers with a favourable response.

The Technical Sessions at 12.00 was flagged off with a presentation on 'Pariksha Parv' by Shri Paresh Shah, NCPCR team. He spoke on the core issues of sensitization on stress due to exams, promote counseling and positive perception, to change the outlook of children towards exam and to bring positive impact through social media platforms, to provide expert advice on exam related stress, to compile a compendium of local level counselors, psychologist and provide this list to all students concerned. The first Session from 12.30 was conducted by Dr. Sujata Satapathy, Department of Psychiatry, All India Institute of Medical Science (AIIMS), New Delhi, on the topic "Clinical aspects of Stress and Anxiety and ways to deal with Exams and Exams Results related to Stress and Anxiety".

Dr Satapathy, with the help of slides discussed how students approach preparation of exams and also gave tips on how to handle examination stress and how to study. She explained why examination stress is a negative experience



and how the stress manifests itself into excess stress that destroys a student both physically and psychologically.

She also spoke on the concept of delinking in order to reduce stress that surrounds marks, academic goals and examinations. Parental involvement and monitoring can also help a lot when it comes to stress management

The First Technical Session ended with a Lunch break.

The Second Technical Session was presented by Dr. Jyotsna Bharadwaj, Faculty for Diploma in Guidance and Counseling Course, Department of Educational Psychology and Foundations of Education, NCERT, New Delhi. Dr. Bharadwaj elicited a positive and lively response with her empathetic and child friendly form of delivery. She explained how students should work on their coping mechanism to better their mental health. She also urged the students to understand that they will do better only when they feel better. She invited them to focus positively on the whole person, improve emotional, intelligent and social quotients - this will improve their belief on self and their life skills.

Dr Bharadwaj exhorted the students to focus on things that can be controlled and to let go of things that cannot be controlled. She expressed this by quoting " If you cannot stop the storm , you should learn to dance in the rain". The students were taught to focus on the mission of happiness that allows them to understand their thought process and thus improve how they handle stress on a daily basis.

The active response of the students and teachers alike continued in the interactive open house discussion that followed well over the time allotted. The questions that were raised from both the male and female students especially were thought provoking

and honest, addressing issues that were faced by students especially post pandemic. The Two Resource persons did an excellent job of judiciously empathizing as well as challenging and giving guidance, treating the questions in all seriousness and giving them due merit.

Some of the questions raised were:

1. How do we deal with people who stigmatize students who score low marks?

2. Can I accept my exams as a best friend?

3. If we can't cope with our problems, what other viable solutions exists?

4. What if we don't have a good childhood experience? How can we make a better foundation later?

5. There are some judgments that we as students cannot ignore, how can we take it positively as a motivation?

6. We say India is a democratic country but still there are many cases where girls aren't given chances of equality in society. How do we address this?

7. I can't seem to concentrate in class when teachers give lectures. Is there a problem with me?

8. If anyone of you living in the same dream, are you living on it?

Just before the break for high tea, there was another colorful display of traditional attire and musical sound of flute and drums and dance of the same troupe who had entertained earlier.

The excited chatter of students, feedback and conversations of the invitees and guests in the two dining halls reflected the success of the Pariksha Parv program.

The Report of this program would not be complete if we do not acknowledge the excellent work of the NCC Synod College and the interns from MLCU, and the organizers NCPCR and MSCPCR.




