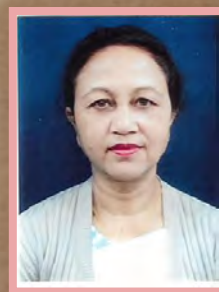
# *From the Desk of the Chairperson.*

# Meghalaya State Commission for Protection of Child Rights

## Vision

In keeping with the vision of the National Commission for Protection of Child Rights, the Mandate of the Meghalaya State Commission for protection of Child Rights, is to ensure that all Laws, Policies, Programmes and Administrative Mechanisms are in consonance with the Child Rights perspective as enshrined in the constitution of India and also the UN Convention on the Rights of the Child. The Child is defined as a person in the 0 to 18 years age group.

The Commission visualizes a rights-based perspective and in order to touch every child, it seeks a deeper penetration to communities and households and expects that the ground experiences gathered at the field are taken into consideration by all the authorities at the higher level. Thus the Commission sees an indispensable role of the the State, sound institution-building processes, respect for decentralization at the local bodies and community level and larger societal concern for children and their well-being.

## Background

With the aim of effectively addressing the issue of protection of child rights in Meghalaya, the State Commission for Protection of Child Rights was set up. The Commission comprised of a Chairperson and six members.

The government of Meghalaya, Social Welfare Department, vide Notification No.SW(S)112/2009/236 dated, Shillong the 28<sup>th</sup> February,2014 under section 4, sub-section(3) of the Commission for Protection of Child Rights act,2005(4<sup>th</sup> of 2006) the Governor of Meghalaya appointed Smti. Meena Kharkongor as Chairperson, State Commission for Protection of Child Rights for a period of 3(three) years with immediate effect.

The Chairperson joined the Commission on 11<sup>th</sup> March,2014 and the office was opened on the 23<sup>rd</sup> may,2014 at Nongshiliang ,Nongthymmai, Shillong with a staff strength consisting of only the Chairperson, one peon and a chowkidar, and the following MEMBERS:

## *Suo-moto Cases filed by the State Commission for Protection of Child Rights.*

1. A 14( Fourteen) year old girl who was trapped into Sex Exploitation for more than a year, upon her escape from her Owner, had disclosed many facts and people who had sexually exploited her, naming some Influential people and after taking due cognizance, the Commission on behalf of the victim survivor has filed as many as 10 (Ten) Complaints with the Superintendent of Police, East Khasi Hills District and the Ri Bhoi District, Meghalaya, where more than 19 (nineteen) people have been arrested and Investigation is proceeding in these cases whereby cases have been charge-sheeted under the POCSO Act., 2012. Interim Victim Compensation to a victim in a particular Gang sexual Assault case, (POCSO) has also been granted by the Special Court upon the application filed by the SCPCR on behalf of the girl.
2. The intervention of the SCPCR into the case of Jawahar Navavidyala School where the children were staying in make- shift premises due to the on- going technicalities of the various departments for the last 10 ( Ten) years was taken up suo-moto. The Chairperson personally inspected the premises, met the aggrieved parents, Principal and students. Written communication was shared with the concerned Authorities by giving them 3 (Three) months notice to shift the students into the new campus. Even after one year of correspondences with the related Departments, works were not progressing and ultimately the SCPCR had to file an Public Litigation Interest Case in the High Court of Meghalaya which was registered as P.I.L. No. 10/ 2016 dated 27.1.2017. Show- causes were issued to the concerned Departments of CPWD and the PHE. As of now, the departments are on the process of sorting out the problems. Follow- up has also been done. The New School will be functional probably by June, 2017 and the students will finally be accommodated in the New premises.
3. The SCPCR also takes up any issue related to the violation of Child Rights, either on complaints or suo- moto and coordinates with the different agencies of the State government to bring justice to the victims of sexual Assaults, or any other offences by ensuring their safety, care and protection.
4. The Draft for the “Child Protection Policy” in Schools etc has been submitted the State Government for their final approval.
5. The SCPCR has launched its Web- Site on 19<sup>th</sup> May, 2017.,for people to have access to the Commission at the official website. Megsepcr.gov.in.
6. On the initiation of the SCPCR and request sent to the Law Department, Govt. of Meghalaya, the Honorable Meghalaya High Court in consultation with the Law Department, shall be setting up exclusive special courts for trial of POCSO cases in the State.

The Guest of Honour, Shri. H.M. Shangpliang, IAS, Director Social Welfare Department, Shillong, Meghalaya firstly, expressed his appreciation and gratitude for the opportunity to be part of the programme. He stated that frequent conducting of such programme will make people aware about the child rights and issues concerning children which will subsequently help in eradicating the issue in the district and the state at large. He also stated that as responsible citizens we should not shy away when we encounter such crimes against children or cases of child abuse instead we should come forward and bring the matter to the notice of the concerned authorities. He also said that child abuse & exploitation is like a disease, if you do not take care of the disease now the disease will keep spreading. He said that every morning when he reads newspaper he sees in the headlines that most of the cases of abuse and assault against women and children occur from this district. Therefore, he urged the people that such crimes should be reported immediately to the authorities for stringent action to enable to stop future perpetrator to repeat the offence or crime. Therefore, it is high time that people wake up and join hands together to fight against such evils”

The Chief Guest, Shri. S. Kharlyngdoh, IAS, Deputy Commissioner, West Khasi Hills highlighted the important roles played by society in our life. He also stated that the society has its responsibility to look after its children. He reminisced his childhood days when he used to play with his friends in the field carefree but as he compares his childhood days with the present day he feels sorry for the children of today as they do not have the opportunity like they had. He also lamented on the current situation prevailing in the society and the rise of child abuse cases. He also said that children are the future responsible citizens and they should not be exploited however they should live in an environment where they will be able to develop mentally, physically and socially. Therefore, he reiterated on frequent conducting of awareness programme to help in changing the mind-set and prospective of society towards issues concerning children. Furthermore, until and unless our society being the primary contact of children changes its prospective on issues such as child abuse and exploitation then this issues will keep rising.

Further, she also spoke on adoption and the process of adoption in accordance with the new adoption guidelines, 2015. The previous Juvenile Justice Act 2000 had limited provision for adoption which has been improved in the new Juvenile Justice Act, 2015 and in the new adoption guidelines 2015 to encourage more adoption of the orphan, surrendered and abandoned child to enable them to have a secure family and future.

**Q. 28. Kumno ki Nongbishar ki lah ban shim bad buh jingthoh ia ka jingiaathuh u/ka khynnah?**

Ki Nongbishar ki lah ban shim bad buh jingthoh ia ka jingiaathuh u/ka khynnah ha ka jingiadon ryngkat ki kmie ki kpa ne kino kino ki briew kiba u/ka khynnah ki don ka jingshahniah. Ki Nongbishar ki dei ruh ban shim ka jingiarap na ki briew kiba la don ka jingbit ha ka kam pynkylla ktien.

**Q. 29. Lada ka nongshah leh kam bymman ka dei ka khynnah kynthei, hato lah ne em ban pyndep ia ka jingsumar da u doktor shynrang?**

Em, ym lah, hynrei, ia kane ka kam dei ban pyndep da ka doktor kynthei ha ryngkat ka jingdon jong ki kmie ki kpa ne kino kino ki briew kiba ka khynnah ka don ka jingshahniah (Sekshon 27).

**Q. 30. Hato ka don ka jingpyrkhing por ban pyndep ia ka jingbishar da ka Iing Bishar ba Kyrpang?**

Lada jia pat ba ki kmie ki kpa ne ki nongsumar kim kot bor ban buh la ki jong ki nongsaid aiñ, ka bor jong ka tnat bishar (*Legal Services Authority*) ka lah ban ai ïa ki nongsaid aiñ khlem kano kano ka jingsiew (Sekshon 40).

**Q. 33. Hano la bynshet ïa ka jingkitkhlieh ban pynlong ïa ki prokram ai jingtip ha kaba ïa dei bad kane ka kyndon aiñ?**

Ka Sorkar Kmie bad Sorkar Jylla ka dei ban ai jingtip lyngba ki lad pathai khubor kum ki telebishon,ki radio,ki kot khubor bad kiwei kiwei ki lad ai jingtip (Sekshon 43).

**Q. 34. Ka don ne em ka jingmana ïa ki lad pathai khubor ba kim dei ban pynpaw eiei ruh em halor ki nongshah leh kam bymman?**

Kat kum ka kyndon Aiñ POCSO, la mana ïa ki lad pathai khubor ban pynithuh ia ki nongshah leh kam bymman la ka long ka kyrting, ka jaka sah, ka longïing longsem, ki jingtip kiba bniah, ki dur ki dar, ka jaka pule, ki shnong ba marjan bad kiwei kiwei (Sekshon 23).

**Q. 35. Ka don ne em ka jingpynsajia haba ki pynpaw ne pynithuh ïaka jinglong ba kyrpang khlem ka jingai bor jong ka ïing Bishar ba Kyrpang?**

Lada kino kino ki briew ki pynpaw ne pynithuh ïa ka jinglong ba kyrpang jong u/ka khynnah khlem ka jingai bor jong ka ïing Bishar ba Kyrpang kin ngat ha ka jingshah set along ba hynriew bnai kaba lah ban pynjlan haduh shisnem ne da ka jingshah daiñ kuna ne baroh ar (Sekshon 23).

**Q. 36. Lah ne em ban ai jingsumar ïa ki nongshah leh bymman lada jia ba ym pat pyndep ïaka jingujor/FIR?**

Wat lada ym pat pyndep ïaka jingujor/FIR lah ban ai jingsumar kat kum ka kyndon Aiñ164A jong ka aiñ leh kam bymman “*Code of Criminal Procedure*” (Sekshon 27).



**Q. 37. Hato ka juh ka aiñ lah ban pynshitom ïa ki khynnah kiba leh kam bymman?**

Kat kum ka kyndon Aiñ POCSO ym lah ban pynshitom ïa ki khynnah da ka juh ka aiñ jingpynshitom, hynrei kine ki hab kat kum ka hok kaba ïa dei bad ki khynnah “*Juvenile Justice*” kaba long ka jingsumar bad jingïada na ka bynta ki khynnah kat kum ka kyndon Aiñ 2000 ba la pynbha pat ha u snem 2006.

**Q. 38. Hato ka don ka jingbuh por ban shim jingtip ïa ki jingjia na ki khynnah da ka Ìing Bishar ba Kyrpang?**

Ho“oid, dei ban pyndep ban shim jingtip ïa ki jingjia na u/ka klhynnah da ka Ìing Bishar ba Kyrpang hapoh laiphew sngi na ka sngi ba ki ïoh jingtip ïa ka jingjia. Hynrei, lada jia ba don ka jingpynslem dei ban shim ïa ki jingtip da kaba buh jingthoh ha ka bui (Sekshon 35).

**Q. 39. Hano la bynshet ïa ka jingkit na ka bynta ban lap ïaka jingshisha kat kum ka Ìing Bishar ba Kyrpang?**

U briew u hap ban pynshisha halor ba un sait hok ba u khlem leh ïa ka kam bymman (Sekshon 29).

**Q. 40. Kat kum ka kyndon Aiñ POCSO, pyrshah ïano lah ban ai ka jingujor?**

Kat kum ka kyndon Aiñ POCSO, lah ban ai ka jingujor ïa u/ka briew kiba leh ne kiba thmu ban leh ïa ki kam bymman.

***Mano u/ka Khynnah?***

Kat kum ka Aiñ halor ka Hok jong ka Pule Puthi,2009 (RTE Act,2009), haba ong “KHYNNAH” ka thew lang kynthei bad shynrang kiba ha ka rta hynriew snem haduh khadsaw snem {tnat kyndon (c) ka kyndon 2}

***Kane ka Aiñ ka kynthup ia kiei kiei?***

Kane ka Aiñ ka kynthup ia ka ri India baroh kawei lait noh tang ka Jammu & Kashmir.

***Ka mut aïu ka kyntien “SKUL” (School) kat kum ka Aiñ halor ka Hok jong ka pule puthi?***

Kino kino ki skul kiba la ithuh bad kiba ai jinghikai ha ka kyrdan ba dang sdang jong ka jingtip ia ka jingpule kiba kynthup ia kine harum:

- a) Ki Skul ba la seng da ki riw shimet ne kiba hab hapoh ka jingpyniaid ka Sorkar Jylla ne ki Shnong.
- b) Ki Skul kiba ioh ia ki lad jingiarap na ka bynta ki jinglut jingsep kiba donkam ban pyntyllun ia ka kam lyngba ki tnat trei kam jong ka Sorkar Jylla ne na ki bor pyniaid Shnong.

***Kiei kita ki Skul ki bym hap hapoh kane ka Aiñ?***

Kino kino ki Skul kiba ai ña ki jinghikai niam kim hap ha kane ka Aiñ.

***Kiei ki lad ki lynti na ka bynta ki khynnah kiba don ka jingthut ha ki dkhot met kat kum kane ka Aiñ?***

Lada jia ba kum kine ki khynnah kim lah ban leit Skul namar ka jingthut ha ki dkhot met, ka Sorkar Jylla ne ki bor pyniaid shnong ki dei ban thaw ka lad ka lynti da kaba pynbiang ña ki kali. {tnat Kyndon 7 jong ka kyndon 6 ka bynta IV RTE Rules}.

***Ka mut aiñ haba ong ki Skul Ba Marjan?***

Kino kino ki Skul kiba don kham pajih naka shnong ba ki khynnah ki leit pule la tip kum ki Skul Ba Marjan.

***Hato ka Aiñ ka don ne em ña u pud naka bynta kine ki Skul Ba Marjan?***

Na ka bynta ki khynnah pule kiba naduh ka kyrda klas 1 haduh klas IV, ki jaka pule ki dei ban long la kumno kumno shi kilo mitar ba ki khynnah kin lah ban ñaid kjat.

Na ka bynta ki khynnah pule naduh klas V haduh klas VIII ki jaka pule ki dei ban long la kumno kumno lai kilo mitar ba ki khynnah kin lah ban ñaid kjat.

***Hato ka don ne em ka jingpynbor ña ki kmie ki kpa ban phah ña ki khun jong ki sha ki jaka pule?***

Ka Article 51(K) jong ka Riti Synshar ka Ri India (Indian Constitution) ka kdew b aka dei ka kamram jong ki kmie ki kpa ban phah ña ki khun jong ki sha ki jaka pule. Kat kum ka Aiñ RTE,2009 ka jingteh ña ka aiñ ka long kat kum ka jingbit jingbiang jong ka Sorkar ban pynioh ña ki khynnah ka hok halor ka pule khlem jingsiew dor naduh ka rta ba hynriew snem haduh ka rta ba khadsaw snem. Ka Kyndon 10 jong ka Aiñ ka pynthikna ba ka dei ka kamram jong ki kmie ki kpa ne ki nongsumar ban pynrung Skul ña ki khun. Hynrei, kam don pat kano kano ka jingpynshitom lada kim phah ña ki khun jong ki sha ki jaka pule.

***Lada jia ba ki khynnah ki leit trei, hato lah ne em ban pynbiang ia ka jingpule ha ki kynta ba la wai Skul?***

Kat kum ki kyndon ba la pynbit pynbiang ha ka Aiñ, n aka bynta ki khynnah primary ka por ai jinghikai ka dei ban long la kumno kumno saw kynta,ia ki kyrdan upper primary pat ka dei ban long la kumno kumno saw ne san kynta. Ka don ka jingbthah ia ki Skul ba ki lah ban ai jinghikai haduh hynriew kynta, kata da kaba kynthup lang n aka bynta kiwei pat ki jingpynbyrngia ia ki khynnah. Kat ka kyndon Aiñ kaba ia dei ban khang ia ki khynnah na kino kino ki kam khia (Child Labour Prohibition and Regulation Act),1986 ka mana pyrshah ban pyn trei ia ki khynnah ha kino kino ki jaka trei kam.

Ka jingthmu jong ka RTE ka long ban pynioh ha ki khynnah ia ka hok halor ka pule puthi khlem kano kano ka jingsiew dor. Ban ai jingpule hadien ki kynta bym dei shuh ka por pule kam long ka jingpynshlur lyngba kane ka Aiñ.

***Hato ki khynnah kiba wan na ki longiing ba kynriah jaka ki don ne em ka hok ban ioh rung skul?***

Ki khynnah kiba wan na ki longiing ba kynriah jaka ki don kajuh ka hok ban ioh rung skul bad ban ioh ka hok halor ka pule puthi. Khnang ba lah ban pynbit pynbiang na ka bynta kine ki khynnah ka Sorkar ka lah ban buh ki jaka shong ha ki skul {tnat kyndon (d) kyndon 2}.

***Kumno yn leh lada u/ka khynnah ki la palat ia ka hynriew snam ka rta bad bym pat sdang leit skul? Hato lah ban pynrung skul? Lada lah ka klas kaba katno yn pynshong?***

Hooïd, lah ban pynrung skul. U/ka khynnah hapdeng ka rta ba 6 – 14 snem ym lah ban kyntait n aka jingpynrung skul. U/ka khynnah lah ban pynrung ha ka klas kaba ia hab bad ka rta. Kata lada jia ba u/ka ki dei 10 snem ka rta dei ban pynshong ha ka klas kaba saw.

***Lada u/ka khynnah kin shong ha klas 4 kin lah mo ban sngewthuh haba kim pat ju leit skul mynno mynno?***

Lada u/ka khynnah kin shong ha klas kaba ia hab bad ka rta jong ki, ki don ka hok ban ioh ka jinghikai ba kham kyrpang. Ka „Jinghikai Ba Kyrpang“ ka long kat kum ka kyndon Aiñ ba la bynshet ia ka jingkitkhlieh ha ki skul ha ka rukom ba kat kum ka por ba la buh {kyndon 4}.

***Lada u/ka khynnah ki la kynjoh ia ka khadlai snem ka rta, hynrei ki kwah ban wan rung skul, hato dei ne em ban phah sangeh noh ia ki tang ha ka snem kaba bud haba kin dap khadsaw snem ka rta?***

Ka Aiñ kam shah ban long kumta, hynrei ki dei ban ioh ia ka jingpule kat kum ba dei ka nongrim/tyndrai. Kumta u/ka khynnah ki don ka hok ban ioh ia ka jingpule ba khlem jingsiew dor haduh ba kin da pyndep ia ka klas 8, la ka long ha kano kano ka rta ba ki kynjoh.

***Mano ban ai ia ka jinghikai ba kyrpang na ka bynta ki khynnah ki ban long ia ryngkat dor ha ka rta jong ki bad kiwei pat ki para khynnah?***

Ki Bor Pyniaid Skul (School Management Committee) la ka long ka skul ki riew shimet hynrei kiba hab hapoh ka jingpeit jong ka sorkar ne ki skul ba la kyrshan da ka dorbar shnong ki don ka jingkit khlieh ban peit bad tip n aka bynta ki khynnah kiba donkam ban ioh ia ka jinghikai ba kyrpang. Ia kum kane ka jait jinghikai dei ban long da ki nonghikai ba la pyntbit, la kumno kumno ia ka jinghikai dei ban pynlong hapoh ka kut jong ka skul ne ha ki karma klas bad ka jaka ai jinghikai ka dei ban long kaba shngaiñ { Rule 5 of Central Rules of RTE 2010 }.

***Lada ki kmie ki kpa jong u/ka khynnah ki kwah pynrung skul ia ki khun ha ka por ba la kut ka por, hato ki nongpyniaid ki don ka hok ban kyntait?***

Wat haba ka por pynrung skul ka la kut ki nongpyniaid kim don hok ban kyntait. Hynrei haba u/ka khynnah ki la duh ia ki jinghikai donkam pat ban ai ka jinghikai ba kyrpang khnang ba u/ka khynnah kin lah ban ia ryngkat bad ki bynta jong ki lynnong ba la pynmang, kane ka jinghiai ba kyrpang dei ban ai hapoh ka skul {kyndon 15}.

***Lada ha ki shnong baka klas pule ka don tang haduh klas V, kaei ka ban jia ia ki khynnah pule hadien kata?***

Kat kum ka Aiñ ki khynnah ki don ka hok ban wad skul shawei(la ka long ka skul ki riew shimet ne ki skul ba ai jinghikai ba kham kyrpang kaba long kat kum ka Aiñ) ba kin pyndep ia ka jingpule kaba la ioh nongrim. Ka long ruh ka jingkit khlieh jong ki nongpyniaid shnong ba khmih bad jngoh ba ki khynnah kin ioh rung ha ki skul ba marjan shnong ha ka por ba biang. Ka sorkar kaba dei ha ka pule puthi ka dei ruh ban kyntiew ia ki kyrdan pule na ki primary sha ki upper primary {kyndon 5}.

***Kumno yn leh lada jia ba ka skul ka pynslem ban ai ia ka syrnot ban kynriah skul (transfer certificate)?***

Lada jia ba ka skul ka pynslem ban ai ia ka syrnot ban kynriah skul (transfer certificate), kam don kano kano ka daw ban khang ia u/ka khynnah ban rung skul. Ki nongpyniaid skul ne u/ka khlieh jong ka skul ha kaba u/ka khynnah ki pule ha shuwa kin hab ban shim ia ka jingkit khlieh bad lah ruh ban ngat ha kino kino ki juingshah pynshitom {kyndon 5}.

***Kumno pat ia ki skul ki bym lah ban kot ia ka kyrdan ba dei ban don kat kum ba la mang da ka Aiñ?***

Lada jia ba don kum kine, ka skul ka hab ban pynbiang ia ka jingdonkam kaba long kat kum ka jingdawa ia ka kyrdan pule hapoh 3 snem naduh ka tarik ba la pynbna ia ka Aiñ jong ka RTE (1st April,2010). Hynrei, lada jia ba ka skul kam pheil hapoh ka por ba la buh, ka jingithuh ia ka skul yn weng noh {kyndon 19}.

***Kiei kiba don ka jingkitkhlieh ban ai ka jingsngew skhem na ka bynta ka hok halor ka pule puthi?***

Ka Sorkar kaba kynthup ia ka Sorkar Pdeng, ka Sorkar Jylla, ki dorbar shnong, ki Nongpyniaid Skul, ki Skul bad ki nonghikai ban ai ka jingsngew skhem bad kiba don ka jingkitkhlieh na ka bynta ka hok halor ka pule puthi ha ka Ri India.

***Hato ka skul ka lah ban long ka jingkhang lad lada ym ka jingpynthikna n aka bynta ka sngi kha?***

Kat kum kyndon 14(2) ym lah ban khanglad ia u/ka khynnah ban rung skul tang na ka bynta ka jingbym thikna ia ka sngi kha.

***Hato lah ne em ban beh noh shisyndon ia u/ka khynnah namar lada jia ba u/ka ki leh kam runar?***

Em {kyndon 16}.

***Bun na ki skul la seng khlem ka jingithuh bad pdiang. Kaei kaba kane ka Aiñ ka don ban leh?***

Lait na ki skul sorkar, kiwei pat ki skul kim lah ban pyniaid shaphrang lada ym pat pdiang ne ithuh naduh ba la pyntrei kam ia kane ka Aiñ.

***Kaei ka ban jia lada ka skul ka kut jingmut ban pyniaid shaphrang khlem ioh ia ka jingithuh?***

Lada jia kumne ka skul kan hab ha ka jingshah daiñ kuna haduh shilak tyngka, hynrei lada kim suidñiew bad bteng khlem da salia ka jingshah daiñ kuna kan long 10,000/- (shiphewhajar) shi sngi.

***Kaei ka ban jia lada ki khynnah ki pule ha ki skul bym shym la ithuh?***

Lada jia ba long kumne dei ban pynrung skul ia ki khynnah ha ki jaka pule ba kham jan bad dei ban leh kham kloï.

***Kumno pat ki skul ba pyniaid da ki Seng Bhalang?***

Kine ruh ki hap ha kajuh hi ka kyndon.

***Hato ki kmie ki kpa ki don bynta eiei ha ka skul?***

Ka Aiñ ka kdew ba ha ka Komiti Pyniaid Skul (Management Committee) lain a ka saw bynta ki kmie ki kpa ki dei ban long ki dkhot, khamtam na ki khynnah kiba wan na ka longging u pud ka jingkyrduh bad la kumno kumno sanphew na ka shispah ki dkhot ki dei ban long ki kynthei.

## *Ki Jingyuntip Na Ka Bynta Ki Jingeh*

### ***Lada ia ki Hok jong ka pule puthi kim leh bym suid ñiew, shano lah ban phah ia ka jingujor?***

İa ka jingujor lah ban phah sha ka Gram Panchayat ne sha ka ophis trei kam jong ka Block kaba dei khmih ia ka pule puthi (Block Education Office) bad lah ruh ban phah sha ka SCPCR ne NCPCR. Ha kaba kut lah ruh ban phah ia ka jingujor sha ki İing Bishar, namar ia mynta hi ka pule puthi ka dei ka bynta ba kongsan bad ba lah ban iada ia baroh ki khynnah kiba hapoh ka rta 6 -14 snem ka rta.

Ka NCPR ka long ka jaka pdeng ban pynpoi ia ki jingujor. Na kane ka tnat jingiarap kin buh ha ka bui jingthoh ia ki jingujor bad ban pynpoi pat sha ka ophis trei kam jong ka pule puthi ryngkat ka jingbud dien na ka por sha ka por.

### ***Lada ka jingrai halor jingujor ba la ai da ki bor pyniaid shnong kam ai ka jingsngew biang ne sngew hun kumno yn leh?***

Lada jia ba ka long kumne lah ban phah biang ia ka jingujor ba thymmai sha ka ophis trei kam kaba ai jingiaada na ka bynta ka hok ki khynnah “State Commission for Protection of Child Rights” ne sha kano kano ka bor trei kam ba la pynkup bor da ka sorkar lada jia ba ka “State Commission for Protection of Child Rights” kam pat don.
